Team responded to a *Medical Incident* at Purok 6, Baculud, City of Ilagan, Isabela last *August 17, 2021*. After immediate intervention by Emergency Care Assistants the patient was properly endorsed to Brgy. Baculud Health Center.







Team responded to a *Trauma-Fall Incident* at Infront of Mitsubishi Calamagui, City of Ilagan, Isabela last *August 10, 2021*. The patient suffered laceration and contusion at chin area, swelling of upper chin, positive alcohol intake as verbalize by the victim. After immediate intervention, the patient was brought to GFNDySMH for proper disposition.







Team responded to a *Trauma Incident* at Upi, Gamu, Isabelanear at St. Micahel Cathedral last *August 15, 2021.* The patient chest pain, dizziness, headache, Abrasion at both hands and chain. After the Emergency Care Assistants (ECA) interventions, the patient was immediately brought to GFNDSMH.







Provided *Medical Evacuation (MEDEVAC*) to a patient consider brain tumor (quadriparesis) who suffered had headache, body weakness, dizziness, progressive weakness on lower extremities. The patient was transferred from Magsaysay Naguilian, Isabela to Premiere Medical Center, Cabanutuan City, Nueva Viscaya last August 11 2021.







Provided *Medical Evacuation (MEDEVAC*) to a patient Covid-19 confirmed-critical-recovered and critical pneumonia – resolved. The patient was transferred from Blk 7 Lot 101, Brgy. Bayugo, Meycauayan, Bulacan to Sisim Alto, Tumauini, Isabela last August 28, 2021.






