PROJECT SUPPLY AND DELIVERY OF P1.8 LED WALL, 1.86MM PIXEL PITCH,
INDOOR MOVABLE LED DISPLAY, SIZE: 2.66 METER (HEIGHT) X 3.84 METER
(LENGTH)**

WHEREAS, the Bids and Awards Committee posted an Invitation to Bid for the project Supply and Delivery of P1.8 LED WALL, 1.86mm Pixel Pitch, Indoor Movable LED Display, Size: 2.66 Meter (Height) x 3.84 Meter (Length) of PGI in the PhilGEPS, Website of the Provincial Government of Isabela and in three conspicuous places within the premises of the provincial capitol and intends to apply through the General Fund the sum of Three Million Nine Hundred Thousand Pesos & 00/100 (₱3,900,000.00) being the Approved Budget for the Contract (ABC);

WHEREAS, in response to the said advertisement, two (2) bidders purchased bid at the Provincial Treasurer's Office, Capitol, City of Ilagan, Isabela;

WHEREAS, the Bidders submitted their sealed bid envelopes before 10:00 A.M. on September 22, 2023;

WHEREAS, on the scheduled Bid Opening on September 22, 2023 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela, the bid opening had failed due to the inability to establish the required quorum;

WHEREAS, on the same date, the Bids and Awards Committee issued a Notice of Postponement and rescheduled the bid opening on September 28, 2023, posted the notice in the PhilGEPS, at the website of PGI and conspicuous places within the premises of the Provincial Capitol;

WHEREAS, on September 28, 2023, there has been another failure of bid opening for the reason that the number of BAC members present was not sufficient to constitute a quorum;

WHEREAS, on October 6, 2023, there has been a motion from the end user unit to

revise the technical specifications of the equipment to be procured to include in the requisition of LED Wall additional features that will enhance its appearance;

WHEREAS, the aforementioned revision of the technical specifications would likewise result to the modification of the bid, hence, affects the procurement process;

WHEREAS, Section 35.6 of the 2016 Revised IRR of Republic Act No. 91 84 authorizes the BAC, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities for any justifiable reason;

WHEREAS, after due deliberation and consultation with the end-user unit, the Bids and Awards Committee deemed it necessary to cancel the conduct of procurement activities in order to revise the technical specifications of the project and assess its effect on the Approved Budget of the Contract;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED: to CANCEL the conduct of the procurement proceedings for ITB No. 2023-G-025/Lot 2 by virtue of the authority granted to it under Section 35.6. of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184.


