DECLARATION OF FAILURE OF BIDDING FOR THE FIRST TIME FOR THE PROJECT SUPPLY AND DELIVERY OF TWELVE (12) UNITS BRAND NEW MPV 2800CC, 4 CYLINDERS, A/T WITH 3 YEARS LTO REGISTRATION/ITB NO. 2023-G-025/LOT 1

WHEREAS, the Provincial Government of Isabela (PGI) advertised an Invitation to Apply for Eligibility and to Bid for the Supply and Delivery of Twelve (12) Units Brand New MPV 2800cc, 4 Cylinders, A/T with 3 Years LTO Registration/ITB No. 2023-G-025/lot 1 on August 25, 2023 and posted the same for seven (7) days in the PhilGEPS, Website of the Provincial Government of Isabela and at conspicuous places within the premises of the Provincial Capitol;

WHEREAS, the Approved Budget of the Contract amounts to Seventeen Million Three Hundred Eighteen Thousand Four Hundred Pesos & 00/100 (₱17,318,400.00), Philippine Currency;

WHEREAS, in response to the aforesaid advertisement, one prospective bidder purchased bidding documents on August 31, 2023 at the Provincial Treasurer's Office and the corresponding bidding documents was issued to the prospective bidder on even date;

WHEREAS, on the bid opening on October 9, 2023, the lone bidder was disqualified in the preliminary examination of bids for not meeting the Single Largest Completed Contract (SLCC) requirement;

WHEREAS, Section 35.1 (b) of the Revised IRR of R.A 9184 provides that the Bids and Awards Committee (BAC) shall declare the bidding a failure when "all bidders are declared ineligible";

WHEREAS, Section 35.3 of the same Act provides that should there occur a failure of bidding, the Procuring Entity may conduct a rebidding of the project with re-advertisement and/or posting;

NOW, THEREFORE, We, Members of the BAC hereby RESOLVE, as it is hereby resolved, to recommend the Declaration of **FIRST FAILURE OF BIDDING** for the abovementioned Project and conduct a re-bidding for the second time.
