**WHEREAS**, the Provincial Government of Isabela advertised the Invitation to Apply for Eligibility and to Bid for the Supply and Delivery of Brand-New Medical Ambulance, 2800cc, 4 Cylinder, Diesel, M/T High Level Medical Ambulance set-up, DOH Compliant with 3-Years LTO Registration /ITB No. 2023-G-028/Lot 1 for the Province of Isabela on September 28, 2023, posted the same at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol continuously for 7 days;

**WHEREAS**, in response of the advertisement, two (2) Bidders purchased bid documents on September 28, 2023 (1<sup>st</sup> bidder) and October 16, 2023 (2<sup>nd</sup> bidder) at the Provincial Treasurer's Office, Capitol, City of Ilagan and the corresponding bid documents for the said project were issued by the BAC Secretariat at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

**WHEREAS**, on the deadline of submission of bids on or before 10:00 a.m. of October 16, 2023, only one (1) Bidder submitted its Letter of Intent and Application for Eligibility and bid envelope;

**WHEREAS**, the Bid Opening was conducted on October 16, 2023 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;


