WHEREAS, the two (2) Bidders submitted their bids including the eligibility documents before 10:00 A.M. on October 18, 2023;

WHEREAS, the Bid Opening was conducted on October 18, 2023 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;


