WHEREAS, in response to the said advertisement, one (1) Bidder submitted a Letter of Intent and Application for Eligibility on February 20, 2023;

WHEREAS, the Bid Opening was conducted on February 20, 2023 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;
