WHEREAS, the Provincial Government of Isabela advertised the Invitation to Apply for Eligibility and to Bid for the Supply and Delivery of Two (2) Units Ambulance, Engine Displacement: Between 2.2L to 2.5L, 4 In-Line, DOHC, Diesel with 3 Years LTO Registration/ITB No. 2023-G-026/Lot 2 for the Province of Isabela on September 8, 2023 posted the same at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol continuously for 7 days;

WHEREAS, in response to the said advertisement, one (1) Bidder submitted a Letter of Intent and Application for Eligibility on September 27, 2023;

WHEREAS, one (1) Bidder purchased bid documents on September 21, 2023 at the Provincial Treasurer's Office, Capitol, City of Ilagan and the corresponding bid documents for the said project was issued by the BAC Secretariat at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

WHEREAS, only one (1) Bidder submitted its bid including the eligibility documents before 10:00 A.M. on September 27, 2023;

WHEREAS, the Bid Opening was conducted on September 27, 2023 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;

WHEREAS, during the bid opening on September 27, 2023, the lone bidder passed the preliminary examination, to wit;


