WHEREAS, to effect responsive, accessible, comprehensive, efficient and immediate response to procure computer desktop for DepEd Simanu Norte Elementary School, Simanu Norte, San Pablo, Isabela use, there is a need to procure goods using the Small Value Method of Procurement;

WHEREAS, in compliance with Section 53.9 of the RIRR, the committee invited suppliers to participate in the procurement and to submit their respective bid quotations;

WHEREAS, upon obtaining the price quotations, the BAC has validated the technical, legal and financial capabilities of supplier to supply and deliver the procuring items;

WHEREAS, upon confirmation of such capabilities and due deliberation of the submitted price quotations, found the offer of SENTRO.COM ENTERPRISES has the lowest calculated and responsive bid;
