WHEREAS, upon obtaining the price quotations, the BAC has validated the technical, legal and financial capabilities of supplier to supply and deliver the procuring items;

WHEREAS, upon confirmation of such capabilities and due deliberation of the submitted price quotations, found the offer of MALABANAN'S NURSERY AND LANDSCAPING CONTRACTOR has the lowest calculated and responsive bid;
