Agency to Agency Agreement

WHEREAS, it is the general policy of government that all procurement shall be done through open and competitive public bidding as stated in Section 10 of RA 9184, except those provided for in Article XVI of the same Act or Alternative Methods of Procurement.

WHEREAS, the Alternative Methods of Procurement under section 48.1 of the 2016 Revised Implementing Rules and Regulations of RA 9184 (RIRR) provides that "Subject to the prior approval by the Head of the Procuring Entity and whenever justified by the conditions provided in this Act, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in this Rule. In all instances, the Procuring Entity shall ensure that the most advantageous price for the Government is obtained."

WHEREAS, Negotiated Procurement is one of the alternative methods of procurement as stated under Section 53 of the same IRR whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant;

WHEREAS, Agency to Agency is one of the cases wherein Negotiated procurement is allowed as provided under Section 53.5 of the 2016 RIRR;

WHEREAS, Annex "H" of the same IRR enumerates the conditions for the Agency-to-Agency Procurement as follows: (i) The Procuring Entity shall justify that entering into an Agency-to-Agency Agreement with the Servicing Agency is more efficient and economical to the government (ii) Servicing Agency has the mandate to deliver goods and services required to be procured or to undertake the infrastructure project or consultancy required by the Procuring Agency (iii) Servicing Agency has the absorptive capacity to undertake the project (iv) Servicing Agency owns or has access to the necessary tools and equipment required for the project;

WHEREAS, Agency to Agency Procurement is the more and efficient and economical for the Provincial Government of Isabela, having also met the conditions stated under Annex "H" 5.5 of the RIRR;

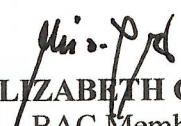

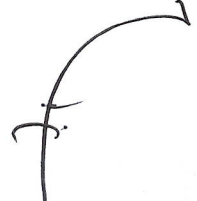

RESOLVED, this 21st day of DECEMBER, 2022 at the Bids and Awards Committee Office, Alibagu, City of Ilagan, Isabela.

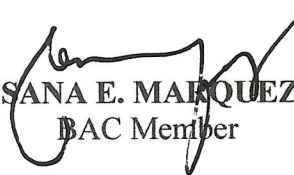
