RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO ISAIAH 8:15 ENTERPRISES THROUGH NEGOTIATED PROCUREMENT UNDER EMERGENCY CASES IN THE PROCUREMENT OF VARIOUS OTHER SUPPLIES FOR STOCKPILING USE

WHEREAS, Section 53 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Negotiated Procurement whereby the Procuring Entity directly negotiated a contract with a technically, legally and financially capable supplier, contractor or consultant;

WHEREAS, in Section 53.2 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Emergency Cases as a Negotiated Method of Procurement of Goods;

WHEREAS, Emergency Cases is a method of Procurement of Goods may be resorted to in case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities;

WHEREAS, Presidential Proclamation No. 57 dated September 12, 2022 has been issued to further the extension of the period of State of Calamity throughout the Philippines due to Corona Virus Disease 2019 declared under Proclamation No. 929, S. 2020, as extended under Proclamation No. 1021, S. 2020 and Proclamation No. 1218, S. 2020

WHEREAS, in compliance with Section 53.2 of the RIRR, the committee invited suppliers to participate in the procurement and to submit their respective bid quotations;

WHEREAS, upon obtaining the price quotations, the BAC has validated the technical, legal and financial capabilities of supplier to supply and deliver the items to be procured;

WHEREAS, upon confirmation of such capabilities and after due deliberation of the submitted price quotations, the BAC found the offer of ISAIAH 8:15 ENTERPRISES to be the lowest calculated and responsive bid;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE, HEREBY RESOLVES AS IT HEREBY RESOLVED TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO, III, THE AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER EMERGENCY CASES TO ISAIAH 8:15 ENTERPRISES FOR THE PROCUREMENT OF VARIOUS OTHER SUPPLIES FOR STOCKPILING USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 53.2 OF R.A. 9184;
