**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO  
CABAGAN HIGH VALUE CROPS PRODUCERS ASSOCIATION  
THROUGH NEGOTIATED PROCUREMENT UNDER COMMUNITY  
PARTICIPATION PURSUANT TO SECTION 53.12 OF THE REVISED  
IRR OF RA 9184 IN THE PROCUREMENT OF VARIOUS FRUIT TREE  
SEEDLINGS UNDER THE ISABELA RECOVERY INITIATIVES TO  
SUPPORT ENTERPRISES (I-RISE) PROGRAM**

**WHEREAS**, Section 11 of Republic Act No. 11321 or the “Sagip Saka Act” enacted on April 17, 2019 requires national and local government agencies to promote and support farmers and fisherfolk enterprise development by directly purchasing agricultural and fishery products from accredited farmers and fisherfolk cooperatives and enterprises;

**WHEREAS**, 2<sup>nd</sup> paragraph of Section 11 of Republic Act No. 11321 provides that the procurement by national and local government agencies of said agricultural and fishery products shall be exempt from the application of the bidding process prescribed under relevant government procurement laws: Provided, that said agencies shall undergo a negotiated procurement under the applicable guidelines of the GPPB;

**WHEREAS**, the GPPB issued Resolution No. 18-2021 approving the amendment to Section 53.12 of the 2016 revised IRR of RA 9184 otherwise known as the Government Procurement Reform Act, and the Guidelines for the Conduct of Community Participation in Procurement;

**WHEREAS**, Section 53.12 of the 2016 Revised IRR of RA 9184 which provides for Community Participation under Negotiated Procurement, states that:

“Community Participation. Where, in the interest of project sustainability or to achieve certain specific social objectives, it is desirable in selected projects, or its

components, to call for participation of local communities THROUGH COMMUNITY OR SOCIAL GROUPS, OR MEMBERS THEREOF in the delivery of Goods and Simple Infrastructure Projects, subject to the GUIDELINES issued by the GPPB”;

**WHEREAS**, Section 4, Item No. 4.2 of GPPB Resolution No. 18-2021 further states that Community Participation is most appropriate when the:

1. involvement of people in the community, in part or whole, is necessary to sustain the project outputs and achieve its intended outcomes;
2. empowerment of local communities through CSGs and members thereof is promoted by enhancing their knowledge and skills, and creating an environment for development; or
3. participation of Local Farmer and Local Fisherfolk is necessary to ensure the availability of food for the target community or to improve their economic, environmental, and social well-being;

**WHEREAS**, the above-mentioned association is duly registered with the Department of Labor and Employment with DOLE Registration No. RO2-IFO-WA-1-2023-53442 and with office address at P7, Cubag, Cabagan, Isabela, producing various fruit tree seedlings through its farmer-members and is needing support for their association such as, but not limited to, production, processing, marketing, and promotion of their produce;

**WHEREAS**, upon obtaining the price quotations, the BAC has validated, with due diligence, the technical, legal and financial capabilities of supplier to supply and deliver the items to be procured;

**WHEREAS**, upon confirmation of such capabilities and after due evaluation of the submitted price quotations, the BAC found that the offer of the association has the lowest calculated and responsive quotation;

**NOW THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT TO CABAGAN HIGH VALUE CROPS PRODUCERS ASSOCIATION THROUGH NEGOTIATED PROCUREMENT UNDER COMMUNITY PARTICIPATION PURSUANT TO SECTION 53.12 OF THE REVISED IRR OF RA 9184 IN THE PROCUREMENT OF VARIOUS FRUIT TREE SEEDLINGS UNDER THE ISABELA RECOVERY INITIATIVES TO SUPPORT ENTERPRISES (I-RISE) PROGRAM.**
