RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO ISABELA PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE THROUGH NEGOTIATED PROCUREMENT UNDER COMMUNITY PARTICIPATION OF SECTION 53.12 OF THE REVISED IRR OF RA 9184 IN THE PROCUREMENT OF GROCERY PACK FOR DISTRIBUTION TO PGI EMPLOYEES DURING CHRISTMAS PARTY USE

WHEREAS, Republic Act (RA) No. 9184 entitled "An Act Providing for the Modernization, Standardization and Regulation of the Procurement Activities of the Government and For Other Purposes," took effect on 26 January 2003, while its 2016 Revised Implementing Rules and Regulations (IRR) took effect on 28 October 2016;

WHEREAS, on 23 May 2014, the GPPB issued Resolution No. 09-2014 approving and adopting the Community Participation Procurement Manual (CPPM), providing for the Guidelines for Negotiated Procurement under Section 53.12 (Community Participation) of the IRR of RA 9184;

WHEREAS, Section 53.12 of the 2016 Revised IRR of RA 9184 allows resort to Negotiated Procurement under Community Participation modality where, in the interest of project sustainability or to achieve certain specific social objectives, it is desirable in selected project components to call for participation of local communities in the delivery of goods, including non-consulting services, and simple infrastructure projects, subject to the Community Participation Procurement Manual issued by the GPPB;

WHEREAS, Rule XVI Section 53.12 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Community Participation under Negotiated Procurement;

WHEREAS, Section 53.12 of the 2016 revised IRR of RA 9184 provides that:

Community Participation. Where, in the interest of project sustainability or to achieve certain specific social objectives, it is desirable in selected projects, or its components, to call for participation of local communities THROUGH COMMUNITY OR SOCIAL GROUPS, OR MEMBERS THEREOF in the delivery of Goods and Simple Infrastructure Projects, subject to the GUIDELINES issued by the GPPB;

WHEREAS, upon obtaining the price quotations, the BAC has validated, with due diligence, the technical, legal and financial capabilities of supplier to supply and deliver the items to be procured;

WHEREAS, upon confirmation of such capabilities and after due deliberation of the submitted price quotations, the BAC found the offer of cooperative has the single calculated and responsive quotation;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT TO ISABELA PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE THROUGH NEGOTIATED PROCUREMENT UNDER COMMUNITY PARTICIPATION OF SECTION 53.12 OF THE REVISED IRR OF RA 9184 IN THE PROCUREMENT OF GROCERY PACK FOR DISTRIBUTION TO PGI EMPLOYEES DURING CHRISTMAS PARTY USE, PURSUANT TO AND IN **ACCORDANCE WITH SECTION 53.12 OF R.A. 9184;**
