RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO MALABANAN'S NURSERY AND LANDSCAPING CONTRACTOR THROUGH SMALL VALUE PROCUREMENT UNDER NEGOTIATED PROCUREMENT IN PROCURING. ASSORTED FRUIT BEARING TREE SEEDLINGS FOR DISTRIBUTION TO REQUESTING ORGANIZATION/INDIVIDUALS/SMALL-FARMERS FOR VARIOUS CLIMATE CHANGE MITIGATION/ADAPTATION AND DISASTER RISK REDUCTION AND MANAGEMENT ACTIVITIES IN THE PROVINCE OF ISABELA USE

WHEREAS, Section 53 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Negotiated Procurement whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant;

WHEREAS, in Section 53.9 of the Revised Implementing Rules and Regulations allows procurement of goods not covered by Shopping under Section 52 of the IRR of RA 9184, where the amount involved does not exceed P1,000,000.00 in the case of 1st Class Province, among others;

WHEREAS, to effect responsive, accessible, comprehensive, efficient and immediate response to procure various other supplies for distribution to requesting organization/individuals/small-farmers for various Climate Change Mitigation/Adaptation and Disaster Risk Reduction and Management activities in the Province of Isabela use, there is a need to procure goods using the Small Value Method of Procurement;

WHEREAS, in compliance with Section 53.9 of the RIRR, the committee invited suppliers to participate in the procurement and to submit their respective bid quotations;

WHEREAS, upon obtaining the price quotations, the BAC has validated the technical, legal and financial capabilities of supplier to supply and deliver the items to be procured;

WHEREAS, upon confirmation of such capabilities and after due deliberation of the submitted price quotations, the BAC found the offer of MALABANAN'S NURSERY AND LANDSCAPING CONTRACTOR to be the lowest calculated and responsive bid;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO, III, THE AWARD OF CONTRACT TO MALABANAN'S NURSERY AND LANDSCAPING CONTRACTOR THROUGH SMALL VALUE PROCUREMENT UNDER NEGOTIATED PROCUREMENT IN PROCURING ASSORTED FRUIT BEARING TREE SEEDLINGS FOR DISTRIBUTION TO REQUESTING ORGANIZATION/INDIVIDUALS/SMALL-FARMERS FOR VARIOUS CLIMATE CHANGE MITIGATION/ADAPTATION AND DISASTER RISK REDUCTION AND MANAGEMENT ACTIVITIES IN THE PROVINCE OF ISABELA USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 53.9 OF R.A. 9184;
