RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO SUPREME CLASS ELECTRICAL TIRES AND AUTO SUPPLIES THROUGH SMALL VALUE PROCUREMENT UNDER NEGOTIATED PROCUREMENT IN PROCURING TIRES FOR VOLVO GRADER G930 PN: 230-07-11-06-1539A USE

WHEREAS, Section 53 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Negotiated Procurement whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant;

WHEREAS, in Section 53.9 of the Revised Implementing Rules and Regulations **allows** procurement of goods not covered by Shopping under Section 52 of the IRR of RA **9184**, where the amount involved does not exceed P1,000,000.00 in the case of 1st Class Province, among others;

WHEREAS, to effect responsive, accessible, comprehensive, efficient and immediate response to procure tires for Volvo Grader G930 PN: 230-07-11-06-1539A use, there is a need to procure goods using the Small Value Method of Procurement;

WHEREAS, in compliance with Section 53.9 of the RIRR, the committee invited suppliers to participate in the procurement and to submit their respective bid quotations;

WHEREAS, upon obtaining the price quotations, the BAC has validated the technical, legal and financial capabilities of supplier to supply and deliver the items to be procured;

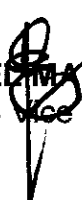

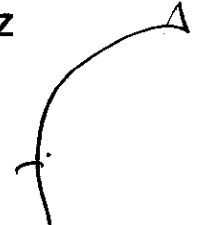

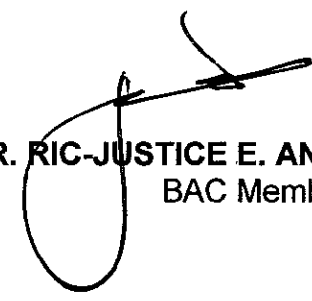
