WHEREAS, the Provincial Government of Isabela advertised the Invitation to Apply for Eligibility and to Bid for the **Supply and Delivery of Medical Supplies /ITB No. 2024-G-008/Lot 2** for the Province of Isabela on March 8, 2024, posted the same at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol continuously for 20 days;

WHEREAS, in response to the said advertisement, two (2) Bidders submitted their Letter of Intent and Application for Eligibility on March 27, 2024;

WHEREAS, two (2) Bidders purchased bid documents at the Provincial Treasurer's Office, Capitol, City of Ilagan and the corresponding bid documents for the said project were issued by the BAC Secretariat at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

WHEREAS, the two (2) Bidders submitted their bids including the eligibility documents before 10:00 A.M. on March 27, 2024;

WHEREAS, the Bid Opening was conducted on March 27, 2024 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;

WHEREAS, during the bid opening on March 27, 2024, the preliminary examination of bids resulted to, as follows:

- A. To declare **GCMED Pharmaceutical Distributor** as the Lowest Calculated and Responsive Bidder for the Supply and Delivery of Medical Supplies /ITB No. 2024-G-008/Lot 2 for the Province of Isabela.
- B. To recommend the award of contract for approval by the HON. RODOLFO T. ALBANO, III, Governor to the above stated Lowest Calculated and Responsive Bidder;
