**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO GCMED PHARMACEUTICAL DISTRIBUTOR THROUGH SHOPPING UNDER ALTERNATIVE METHODS OF PROCUREMENT IN THE PROCUREMENT OF MEDIUM CAPACITY BENCHTOP CENTRIFUGE FOR ECHAGUE DISTRICT HOSPITAL – LABORATORY USE**

**WHEREAS**, as a general rule, all procurement shall be done through competitive bidding except resort to any of the alternative methods of procurement may be allowed when justified by the conditions in order to promote efficiency and economy;

**WHEREAS**, Rule XVI Section 52 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Shopping as an Alternative Method of Procurement of Goods;

**WHEREAS**, Shopping is a method of Procurement of Goods whereby the Procuring Entity simply requests for the submission of price quotations for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from suppliers of known qualifications;

**WHEREAS**, Section 52.1(a) of the RIRR which provides that this method of procurement shall be resorted to when there is an unforeseen contingency requiring immediate purchase. Provided, however, That the amount shall not exceed the thresholds prescribed in Annex "H" of this IRR have been complied;

**WHEREAS**, Section 52.3 of the Revised Implementing Rules and Regulations requires at least three (3) price quotations from bona fide suppliers shall be obtained;

**WHEREAS**, upon obtaining the price quotations, the BAC has validated the technical, legal and financial capabilities of supplier to supply and deliver the items to be procured;

**WHEREAS**, upon confirmation of such capabilities and after due deliberation of the submitted price quotations, the BAC found the offer of GCMED PHARMACEUTICAL DISTRIBUTOR to be the lowest calculated and responsive bid;

**NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT TO GCMED PHARMACEUTICAL DISTRIBUTOR THROUGH SHOPPING UNDER ALTERNATIVE METHODS OF PROCUREMENT IN THE PROCUREMENT OF MEDIUM CAPACITY BENCHTOP CENTRIFUGE FOR ECHAGUE DISTRICT HOSPITAL – LABORATORY USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 52.1(a) OF R.A. 9184;**
