Contract Agreement

THIS AGREEMENT, made on the 26th day of September 2022 between the **Provincial Government of Isabela** with office address at Provincial Capitol, Alibagu, City of Ilagan, Isabela (hereinafter called the "Entity")

and

Irvine True & Frank Carson Philippines, Inc. represented by Mr. Jumar M. Regala, Authorized Representative, with office address at Unit 1117-1118 Corporate 145 Bldg., Mother Ignacia Ave., Brgy. South Triangle, Quezon City.

WHEREAS, the Entity has invited the Bidder for the Supply and Delivery of Metofluthrin 0.1 percent + Cyphenothrin 6 percent + Piperonyl Butoxide 10 percent for the Province of Isabela (hereinafter called "the Goods") for which the entity accepted the Bid amounted Four Million Nine Hundred Ninety Thousand One Hundred Sixty Pesos and 00/100 (Php 4,990,160.00) of the Supplier for the provision and completion of such goods.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form and Price Schedule, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's Conforme thereto;
 - (1) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
