Contract Agreement

and

WHEREAS, the Entity has invited the Bidder for the Supply and Delivery of Brand New AUV, FX Body, A/C, 2400cc, 4x2, 4 cylinder, Diesel, M/T, with 3 Years LTO Registration for the Province of Isabela (hereinafter called "the Goods") for which the entity accepted the Bid amounted to One Million Seventy Six Thousand One Hundred Pesos and 00/100 \(\text{Php1,076,100.00}\)) of the Supplier for the provision and completion of such goods.

 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's Conforme thereto;
 - (1) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
