- 2. The entirety if the WORKS comprised on this Contract Agreement shall be completed within **One Hundred Fifty (150)** calendar days in accordance with the provision of the Bid Documents

  - Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (i) Eligibility requirements, documents and/or statements;
  - (k) Performance Security;
  - (1) Notice of Award of Contract and the Bidder's conforme thereto;
  - (m) Other contract documents that may be required by existing laws and/or the Entity.
