Nursery Operations & Maintenance Works

For this month of April, we have a seedling stock of **18,421** to include 200 fruit trees seedlings procured. The Office was able to disposed **3,100** assorted fruit and forest trees seedlings to different clients for this month, which include those distributed during the conduct of Farmers' Congress Reloaded at the Municipalities of Aurora, Quezon and San Pablo, Isabela. Due to dry weather conditions, we incurred **1.3%** mortality equivalent to **241** seedlings. The remaining stock balance as of April 30, 2018 at the Provincial Nursery is **15,580**.

Also, the ENR personnel in-charge at the Provincial Nursery was able to collect **585 Ipil** seeds, **52 Tindalo seeds and 50 Sugar Apple (Atis) seeds** for germination/propagation.

1. Forest Protection and Law Enforcement

a. Manning of Checkpoints

The roving team conducted surveillance, foot and mobile patrolling to detect illegal gathering and transport of forest products. They act and respond on tipsters (SMS) reports regarding violations of PD 705. Personnel assigned at Sitio Lagis conduct forest protection activities and at the same time perform nursery activities, maintenance, protection and monitoring of the IDRRIP plantation areas. Members of the ISEP-TF led by this ENRO Personnel also joined the PNP and DENR in the conduct of dismantling of existing sawmills in the whole province.

b. Apprehension/Confiscation of Illegally Gathered/Transported Forest Products

For the month, **644 pieces** CHW lumbers and flitches of different species with a total volume of **11,177.92 board feet** and **6 pieces of Narra Flitches** with a volume of **143.33 board feet** were apprehended in the conduct of forestry laws and enforcement activities thru the combined efforts of PGI-ENRO, ISEP-TF and partner agencies. These apprehended lumbers & flitches are under the custody of PGI-ENRO.

c. Donation of Forest Products

A total of **One Hundred Nine** (109) pieces of Common Hardwood (CHW) species with corresponding volume of **3,360.33 board feet** were already donated to different beneficiaries.



2. <u>Climate Change Mitigation/Adaptation & Disaster Risk Reduction Management</u>

This Office conducted series of ocular inspection and documentation of possible sites for the different projects in support to CCM/A and DRRM programs of the provincial government.

In partnership with LGU Sto. Tomas, Isabela thru the Office of the Municipal Engineer, ENRO personnel conducted inspection to the LGU's proposed site for **Riparian Development Project** along the Cagayan River. As a result, the area with a length of 2.5 kilometers within the

jurisdiction of Barangays San Rafael Abajo, Ammugauan and Canyugan Abajo Norte were recommended suitable for riparian development. With this, the Office prepared and submitted a project proposal for the development of the identified site. Said project proposal was already approved and shall be implemented on set of rainy season to ensure higher survival rate.

A possible site for **Urban Greening Project** was also identified in the Municipality of Sto. Tomas which is a 950-square meter triangular area located at Sitio Culalabo, Barangay Bulinao along the municipal high-way. Additional areas are still subject for identification province-wide.

The office has also conducted its initial coordination with LGU Quezon thru their Municipal ENR Officer for a possible partnership in the establishment of agro-forestry area under the **Agro-Reforestation Project** of the province. Site inspection and documentation of the proposed site shall be held on the month of May 2018.

In coordination with LGU Divilacan and Palanan thru their Municipal ENR Officers, proposed sites for **Mangrove and Beach Forest Rehabilitation** were identified. For this month, project proposal for the rehabilitation of 4-hectares mangrove forests in the Municipality of Divilacan, Isabela has already been prepared and is now subject for approval. On the other hand, project proposal for the beach forest rehabilitation project at the Municipality of Palanan, Isabela is currently under preparation.

Personnel of this Office also conducted site inspection of Bonsai Forest to identify possible intervention for **Bonsai Forest Rehabilitation Project** last April 21-22, 2018 at

Dinapigue, Isabela. As observed, forest cover is still intact and there were no open areas sited possible for rehabilitation. The only open areas seen were the old mining roads which were utilized for monitoring activities. In addition, the DENR Personnel who were with us during the said activity informed that there was no threat of illegal cutting in the Bonsai Forest area; however wildlife hunting was observed to have been rampant hence strict monitoring is being implemented.



3. <u>Inventory of Forest Occupants/Informal Settlers</u>

The ENR Office concerned personnel together with DENR-PENRO, DENR-CENRO Naguilian, City LGU Ilagan and MLGU San Mariano representatives conducted inventory/census of forest occupants/ informal settlers along the vicinities of Ilagan-Divilacan Road Rehabilitation & Improvement Project (IDRRIP) at So. Disipol & So. Lagis last April 24 to 27, 2018. In summary, our team was able to census a total of seventy one (71) forest occupants/informal settlers within and along the road starting from Bigao Crossing (Km. 13) to Sitio Lagis (Km. 18). Most of these informal settlers were from the City of Ilagan and Municipality of San Mariano, Isabela.



4. <u>Search for the Most Environment-Friendly Barangays</u>

During the regular meeting of the Philippine League of Local ENR Officers (PLLENRO) – Isabela Chapter last April 18, 2018, entries received were pre-evaluated thru their submitted

documents. As a result, **9 entries** out of 29 entries from the Municipalities of Burgos, Cabagan, Cabatuan, Cauayan, Dinapigue, Echague, Jones, Quirino and San Isidro were chosen for final site evaluation which shall commence May to June 2018.





5. Updating of the Provincial 10 - Year Ecological Solid Waste Management Plan

The updating of the Provincial 10-Year ESWM Plan in compliance to NSWMC Resolution No. 996 series of 2017 is already completed. Other than some minor editing, said document is now ready for submission to the Office of Director, National Solid Waste Management Commission this May 2018.

6. Vermi-composting Facility

For the month of April 2018, only **Two Hundred kilograms** of vermicasts (organic fertilizer) were produced. The sudden decreased in production was due to the limited organic materials hence personnel assigned concentrated on the collection of animal manure and other organic material.



7. Processing and Issuance of Permits

a. Commercial Sand and Gravel (CSAG) – For the month of April 2018, the office received additional Two (2) CSAG Permit Applications with corresponding administrative/processing fees collected by the Provincial Treasurer's Office amounting to Twenty Two Thousand Six Hundred Sixty (Php 22,660.00) pesos only.

From January to April 2018, a total of **Sixty Six (69)** CSAG Permit applications has been filed with the following status, to wit:

To date, a total of **Three Hundred Forty Three (343)** haulers/dealers/traders and retailers of sand and gravel and other quarry resources were already accredited by the provincial government.

8. Site Verification and Inspection of Mining/Quarry Sites

a. Regular Field Monitoring of Quarry Areas

The ENRO Personnel and ISEP-TF Operative members conduct daily field monitoring in the different quarry areas province-wide. Monitoring reports together with the delivery receipts are submitted regularly in the office. In addition, a mobile team is also conducting its monitoring to validate submitted reports and ensure that the personnel are present in their designated area of responsibility.

For the month of April 2018, 48,829.72 cu.m. quarry resources were extracted representing 3,340.00 cu.m. Boulders, 5,040.71 cu.m. G1/S1, 39,849.01 cu.m. Mixed Gravel and 600 cu.m. Ordinary Earth with corresponding gross tax amounting to One Million Eight Hundred Twenty Three Thousand Two Hundred Forty Seven pesos and 30/100 (Php 1,823,247.30) only.

From January to April, 2018, a total of 316,805.59 cubic meter of quarry resources were monitored to have been extracted with corresponding gross tax amounting to Ten Million Two Hundred Forty One Thousand Three Hundred Fifty Three (Php12,064,600.30) pesos only.

9. Information, Education, Communication Campaign/Social Development Programs

Series of dialogues and meetings were conducted during this reporting month, to wit:

April 20, 2018 – The Provincial Government of Isabela (PGI) in Celebration of Earth Day 2018 conducted various activities at Agta Village Model Community, Cabisera 10, City of Ilagan, Isabela. It was attended by different offices of the PGI namely ENR Office, PSWD Office, OPA and IPHO and was also participated by DENR-PENRO and DENR-CENRO Naguilian. The program started with an IEC meeting with the Agta community wherein the importance of the environment was reiterated. It was followed by medical and dental mission, monthly distribution of food package to the Agta community, Tree Planting activity (Urban greening & gardening) and clean-up drive activity.







April 25, 2018 – A dialogue/meeting was conducted with forest occupants/informal settlers at So. Lagis during the inventory of forest occupants along the vicinities of IDRRIP. The joint team explained to them the purpose of the census especially their illegal occupancy of the forest zones, its consequences and the importance of protecting the Northern Sierra Madre Natural Park in support of IDRRIP. After which, an open forum was conducted wherein issues and concerns of the settlers were noted.

April 2018 26, dialogue/meeting was also conducted at Barangay Minanga, San Mariano with the individuals who occupied portion of forestlands at So. Disipol but only few attended the meeting. Despite their number, the meeting must go on, so the team proceeded with the same dialogue we did in Lagis settlers. After the dialogue, the team requested Barangay Captain Felimon T. Pamittan of Minanga, San Mariano to accompany us on the following day for a meeting and inventory of the other forest occupants at So. Disipol and he agreed.





April 27, 2018 – A dialogue/meeting at So. Disipol was conducted. Same with the previously conducted dialogues with forest occupants, the team explained the purpose of the dialogue, their illegal occupancy of the forest areas, its consequences and the importance of protecting the Northern Sierra Madre Natural Park.

10. Other Activities

a. Attended the 2-day 1st Quarterly Meeting of the Regional Ecology Center led by the DENR – EMB Regional Office where ENR Officer Personnel presented the province's ESWM Accomplishment Report for 2017 and the plans for this year of 2018.



b. Attended the 9th Philippine League of Local Environment and Natural Resources Officers (PLLENRO) National Convention held at the Ritz Hotel Garden Oases, Davao City on April 11-14, 2018.
