A. HEALTH GOVERNANCE

CONDUCT OF MEETINGS

Provincial Local Health Board Meeting - February 4, 2021

The finalization of the COVID-19 Vaccination Plan of the Province of Isabela was among the agenda during the 1st quarter meeting of the Provincial Local Health Board. Anchored along the National Deployment and Vaccination Plan, it was composed of three phases which emphasized the roles of other government agencies to effectively carry out the plans and strategies once the vaccines are available.





Atty. Manuel R. Lopez, Provincial Administrator presided the meeting while Mr. Alexander Arellano from PhilHealth Office gave his insights to the plan.



The PHO I and the Provincial COVID-19 Vaccine Operations Centre Chairperson, Dr. Arlene M. Lazaro, briefly discussed the province' vaccination plan in preparation to the forthcoming COVID-19 vaccination roll-out among priority groups A1, A2, and A3 target population.

The Phase 1 is the **Pre-Implementation** activities which include organizing the Provincial Task Force for COVID-19 and Technical Working Groups, identification of vaccination teams, the masterlisting of eligible population, conduct of COVID-19 vaccine training and micro-planning workshop for municipalities, vaccines logistics and cold chain inventory, and preparation of vaccine sites.

The Phase 2 underscores the **Implementation** activities such as the deployment of vaccination teams and conduct of actual vaccination in the field, underscoring the Infection, Prevention and Control (IPC) measures.

The Phase 3 or the final phase is the **Post-Implementation** activities that include the monitoring and management any post vaccination effects of the immunization, the final disposal of immunization wastes and post campaign meetings and evaluation.

<u>CASCADING OF LOCAL HEALTH SYSTEM-MATURITY LEVEL (LHS-ML) BASELINE</u> <u>ASSESSMENT – February 17-18, 2021</u>

As the province commits to pursue Universal Health Care, a 2-day face-to-face meeting was conducted to present the status of province-wide baseline assessment of Local Health System Maturity Level based on DOH Administrative Order 2020-0037. It was attended by city/municipal health officers and members of the Local Health Board; Result of Baseline Assessment for LHS ML was discussed.



<u>Provincial Program Implementation Review – June 17, 2021</u>

Program Implementation Review (PIR) is one of the annual assessment activities by the Department of Health to determine if the intended results for health have been achieved. Also, to evaluate whether program objectives were met, to identify gaps, good practices, and strategies for future planning, and to ensure that the end-consumers of health get the greatest possible benefit from the health programs despite of the COVID-19 pandemic. Furthermore, the conduct of PIR shall also provide a clear direction for the development of Annual Operational Plan 2022.







Provincial Health Cluster Heads and Program Coordinators presented their health programs by highlighting their accomplishments guided by local and national targets. On the other hand, health gaps were also identified and given ample attention to formulate interventions with adherence to the protocols set by the National/Regional/Provincial IATF against COVID-19. Most of these health gaps were attributed to the COVID-19 pandemic which limited the implementation and delivery of health services.













Guided with a common goal to improve the delivery of services, our participants from PDOHO, Regional Program Managers, MHOs, PHNs, and Program Coordinators actively participated during the discussion. The two (2) Provincial Health Officers I , Dr.Arlene Lazaro and Dr. Imelda Guillermo delivered the Synthesis and Next Steps with Closing remarks respectively.

COVID-19 MONITORING AND RESPONSE

Establishment of the One Isabela COVID-19 Command Center (OICCC) - May 2021

The One Isabela COVID Command Center (OICCC) aims to harmonize the admission and management of COVID-19 patients at the appropriate level of health facilities. In addition, ensuring the prioritization of decking and admission among COVID-19 confirmed, suspect, and probable cases as well as to provide proper and prompt referral to Provincial Department of Health Office (PDOHO) for severe and critical cases that require admission to identified COVID-19 referral hospitals namely, SIMC and CVMC.







Located strategically at GFNDMHS with the IPHO team as in charge on a 24/7 tour of duty. The OICCC was able to serve **1,543** CoviD-19 cases from May to December 2021.

COVID-19 VACCINATION ROLL-OUT - March 2021

Pursuant to the national government's plan which aims to target 70 million Filipinos by 2021, the national government has set target groups —priority and eligible population for the vaccination program. Priority Group A1 or our Frontline Health Workers were the first to get inoculated with COVID-19 vaccine.



ResBAKUNA on Wheels

The Province of Isabela along its theme, "Isabela BIDA, Handa sa Bakuna" campaign launched the "Bakuna on Wheels" which aims to deliver the services among eligible Isabeleños nearer to their homes who could hardly reach their designated vaccination sites due to geographic challenges, epidemic risk, stricter health protocols, and surge of COVID-19 cases. The Bakuna on Wheels was manned by the vaccination teams from the Integrated Provincial Health Office extending the vaccination services in cities and municipalities, government and private offices, and universities.















WE HEAL AS ONE. Aside from other eligible population, our PDLs confined in enclosed facilities were also given the chance to be inoculated with COVID-19 vaccines with the help from our allied health care workers in different line agencies, and volunteers.

Launching of COVID-19 Vaccination for Pediatric 12-17 years old – November 28, 2021

Children of ages 12-17 years old are now eligible to accepting COVID-19 vaccines. Parents are excited for this activity because of the additional protection that vaccines can provide to their children against the severe effects of COVID-19. Provincially-operated hospitals and private hospitals catered the vaccination of our pediatric population with co-morbidities during the launching. Meanwhile, CHOs and RHUs inoculated the Rest of Pediatric Population in their respective areas of responsibility.







Launching of National Vaccination Days – November 29-December 1, 2021

"Bayanihan Bakunahan: Ligtas. Lakas. Buong Pinas."

With the aim of ramping up COVID-19 vaccination nationwide, the Department of Health calls on Filipinos to live out the spirit of bayanihan and participate in the "Bayanihan Bakunahan: Ligtas. Lakas. Buong Pinas" campaign for the National Vaccination Days wherein the Province of Isabela participated during the launching of the event held at the City of Ilagan Medical Center, Brgy Lullutan, City of Ilagan, Isabela. The event was graced by our Provincial and National leaders and was attended by Local Chief Executives, Municipal/City Health Officers, Medical Directors, Provincial Health Officers, and PDOHO Isabela personnel.

As the highlight of the event, 22 municipalities and 2 cities were recognized and awarded for reaching the 70% mark of their target population who were inoculated with first dose of COVID-19 vaccine. They are the following: Luna (100.8%), Reina Mercedes (97.7%), Gamu (91.5%), Cabatuan (82.1%), Mallig (81.9%), Delfin Albano (80.8%), Cauayan City (80.5%), City of Ilagan (80.4%), Quirino (79.5%), Aurora (79.5%), Quezon (78.9%), Burgos (78%), Roxas (76.7%), Angadanan (75.2%), San Manuel (74.7%), Jones (74.3%), Dinapigue (74.2%), Ramon (73.1%), San Guillermo (73%), Naguilian (72.1%), Sta. Maria (71%), San Mariano (70.9%), Benito Soliven (70.4%), Maconacon (70.3%).

CAPABILITY BUILDING

Conduct of Service Capability Mapping

Transition to Universal Health Care- The Universal Health Care (UHC) Act or Republic Act 11223) is anchored on an integrated and comprehensive approach for the Health System to ensure that all Filipinos are health literate, provided with healthy living conditions, and protected from hazards and risks that could affect their health.

The DOH-CV-CHD through the Integrated Provincial Health Office of Isabela, conducted the Service Capability Mapping Orientation via google meet, on September 17, 2021 attended by RHU participants online. AO 2017-0014 states that Service Delivery network as model of care in providing care. SDN as a network of Organization that provide equitable, comprehensive, integrated and continuous good quality health services, based on primary health care approach. It is a patient-centered care; need to understand demand side. In Service capability, we need to understand the distribution, scope and scale of supply side (government and private).

To maintain registry that stores and facilitates uniform minimum required data on both public and private health facilities, updating SDN Mapping to ensure access of clients to all levels of care through the establishment of a referral system –clients are managed and receive care across various components of the network in a systematic manner. One of the objectives is to set the standards of HPCN's and apex hospitals to ensure that the continuum of care is delivered through a people- centered and integrated health systems for standardized network mechanisms.













IPHO Personnel conducted Facility Mapping in various LGUs including municipalities in Geographically Isolated and Disadvantaged Areas (GIDAs) – Palanan, Dinapigue, Quirino, Roxas to name a few.

<u>Disaster Risk Reduction and Management for Health Planning and Orientation – February 23, 24, 26, 2021</u>

In line with the ultimate goal of the National Disaster and Risk Reduction Management Office which is to attain a safer, adaptive and resilient Filipino communities towards sustainable development, the aforementioned activity aims to strengthen the capacity of the Local Government Units and to build the disaster resilience of communities along with institutionalizing arrangements and to reduce disaster risks and enhance disaster preparedness and response capabilities in all levels.

The AO no. 2020-0036 known as the Guidelines on *The Institutionalization of Disaster Risk Reduction and Management for Health in Province-Wide and City-Wide Health Systems*, which serves as a guidance to LGUs and key stakeholders in the institutionalization of DRRM-H in P/CWHS to further ensure a timely, effective, efficient preparedness and response to public health emergencies and disasters, the development of health resilient systems to manage health risks brought about by natural and biological hazards.



Dr. Nelson O. Paguirigan, Provincial Health Officer II, welcomed the participants (attended by City/Municipal Health Officers, City/Municipal Disaster and Risk Reduction Management Officers, and Disaster and Risk Reduction Management for Health Coordinators) with his message of unifying the entire workforce towards a common goal especially during the emerging of this pandemic brought about by COVID-19.



Dr. Arlene M. Lazaro, Provincial Health Officer I, along with the provincial and regional DRRM-H program coordinators, shared their expertise by briefly discussing the Concepts, Guidelines and Principles in Planning including the strategic steps to achieve effective and efficient DRRM-H plan.









<u>Health Promotion Framework Strategy (HPFS) and DOH Playbook Modules Orientation</u> <u>and Planning Workshop – November 23-26, 2021</u>

Health Promotion, as defined by the World Health Organization as the process of enabling people to increase control over, and improve their health by addressing its risk factors, determinants, and root causes of ill health. As guided by the Republic Act 11223 or the Universal Health Care Law, which aims to give direction in transforming the organizational structure and management of health promotion which defines the Health Promotion Framework Strategy to provide guidance in the design and implementation of strategic policies, plans, and programs for Health Promotion in Province-wide and City-wide Health Systems (P/CWHS).

<u>DRRM-H Workshop on Cascading Baseline Assessment and Situational Analysis –</u> November 23-26, 2021

A face-to-face workshop facilitated by the CVCHD's Disaster and Risk Reduction Management- on Health (DRRM-H) program managers which aims to coordinate and integrate local health systems into Province-wide and City-wide Health System through the passage of the R.A 11223 otherwise known as the Universal Health Care Act. To further specify the general procedures and mechanism by which Local Government Units (LGUs), National Government Agencies and key stakeholders can integrate local health system into Provincial/City-wide Healthcare System Administrative Order No. 2020-0037, which contains the Guidelines in Implementation of the Local Health Systems Maturity Level (LHS-ML).

IPHO's National Blood Voluntary Service Program and Dengue Prevention and Control Program Coordinators spearheaded the activity together with Blood Bank Coordinators from GFNDSMH and Philippine National Red Cross-Isabela Chapter during bloodletting. The collaborative effort recorded a total of 144 bags of blood extracted.

The Provincial Health Office conducted Family Planning Month Celebration 2021 participated by Women of Reproductive Age (WRA) and their Husbands together with Barangay Health Workers and Barangay Leaders from the different municipalities of the Province of Isabela last October 27-29, 2021, for a total of 127 participants at San Mariano, San Mateo, and Cabagan.





The program is jampacked with lectures about the benefits and risks of Modern Family Planning Methods and services thereby improving their access to freely choose the methods they prefer. Aside from lectures, a simple question and answer took place in which all the participants enjoyed.
