I. Submitted is the monthly operational accomplishment report of Isabela Provincial Jail covering the period from February 1 - 28, 2021.

SUMMARY

The Isabela Provincial Jail inmates' population for the period is 258.

1. SITUATION UPDATE:

a. On Inmates/detainees Escort and Security:

- For the period, a total of **One Hundred Thirteen** (113) inmates/detainees were escorted and secured while attending Court hearings in the twelve (12) Regional Trial Courts in the Province.

The maintenance of these projects is being supervised by IPJ personnel.

- For the period, this Office has no moral and spiritual activities to inmates due to pandemic covid19 and ordered modified general community quarantine.

- The installation of CCTV Camera inside and within the perimeter premises of the IPJ was already completed and is now operational.


II. Other Concern:

- On February 9, 2021, one (1) PDL/inmate named Bobby Apaga y Pagdilao of legal age, married, farmer and a resident of Brgy. San Miguel, Burgos, Isabela who was charged for the crime of Rape docketed under Criminal Case No. 8484-8488 before the Regional Trial Court Br. 18. Alibagu, Ilagan City, Isabela, and was committed on August 16, 2018, presently a detention prisoner and under the custody of the IPJ met his untimely death due to Cardio Vascular disease, acute myocardial infarction hypertension.

- Handy Craft projects continuously undertaken by inmates, open for sale to the public the income generated will accrue to prisoner concerned.
- Likewise, inmates who has knowledge in carpentry jobs, continuously accepting furniture making as their source of meager income, carpentry tools was already completed, through the initiative of the Provincial Warden.

III. Problems/Recommendation:

- The procurement of fire power of this office is requested and recommended to upgrade old and primitive hand guns which were issued since the activation of Isabela Provincial Jail. This Office is lacking of fire power considering that there were newly hired Prison Guards.
