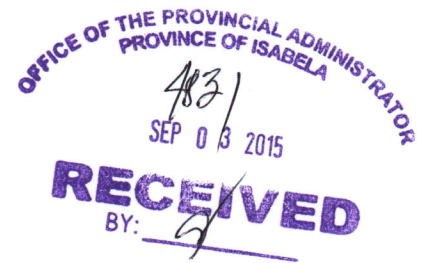

I. Submitted is the monthly operational accomplishment report of Isabela Provincial Jail covering the period from August 1 - 31, 2015.

SUMMARY

The Isabela Provincial Jail inmates' population for the period is 232.

1. SITUATION UPDATE:

a. On Inmates/detainees Escort and Security:

For the period, a total of two hundred fifteen (215) inmates/detainees were escorted and secured while attending Court hearings in the eleven (11) Regional Trial Courts in the Province.

f. Clean and Green Livelihood Program

- For the Period, inmates clean & green program is being undertaken by way of planting different vegetables as their livelihood program, while other inmates were involved in handy Craft projects like basket, table and picture frame making, using cogon as their major materials, others were involved in backyard poultry and piggery projects. The maintenance of these projects is being supervised by IPJ personnel.

h. Recreational Activities:

i. Visitation:

- For the period, relatives and friends of inmates were allowed to visit in this jail every Friday, Saturday and Sunday of the week from 8:00 o'clock in the morning to 4:00 o'clock in the afternoon.

j. Security Consciousness:

- The installation of CCTV Camera inside and within the perimeter premises of the IPJ was already completed and is now operational.
- The hiring of 10 Prison Guards (PG1) under the present administration is of great help in the maintenance of security control inside and outside of the Jail Premises.


II. Other Concern:

- Last August 12, 2015, **Atty. Grace Marcos, Perlita Agana & Henry Dela Cuesta** of the Commission of Human Rights Tuguegarao City, Cagayan appeared in this office to visit minor inmates.
- Last August 20, 2015, **Hon. Felipe Jesus Torio II, Judge** of RTC Branch 22 Cagayan, Isabela appeared in this office for a jail visitation.

- Handy Craft projects continuously undertaken by inmates, open for sale to the public the income generated will accrue to prisoner concerned.
- Likewise, inmates who has knowledge in carpentry jobs, continuously accepting furniture making as their source of meager income, carpentry tools was already completed, through the initiative of the Provincial Warden.

III. Problems/Recommendation:

- The procurement of fire power of this office is requested and recommended to upgrade old and primitive hand guns which were issued since the activation of Isabela Provincial Jail. This Office is lacking of fire power considering that there were newly hired Prison Guards.
