KEY ACCOMPLISHMENTS

As being stated in the Republic Act 7160 also known as the Local Government Code of the Philippines, the Office of the Provincial Planning and Development Coordinator is tasked to be the province's planning arm which is responsible for formulating and updating the development plans and policies of the province.

The year 2022 has brought forth another impressive milestone for the Office in assisting to the province's various programs and in formulating development plans necessary for Isabela's growth, development and welfare.

1. DEVOLUTION TRANSITION PLAN (DTP)

The Supreme Court ruling of Mandanas-Garcia paved way towards local autonomy as being suggested by Republic Act 9160 also known as the Local Government Code of 1991. Also, the Presidential Executive Order (E.O.) No. 138 series of 2021 orders the full devolution of functions, services, and facilities of the national government to the LGUs not later than 2024.

To facilitate this transition, all Local Government Units are required to prepare and formulate their respective Devolution Transition Plans (DTPs). This will serve as a guide in the full assumption of the devolved roles and responsibilities of the national government to the LGUs.

The Provincial Planning and Development Office, being the lead office in the formulation of the Isabela's Devolution Transition Plan, conducted series of review and consolidation of workshop outputs where narrative reports were presented to support the output.

During the 1st Quarter meeting of the Provincial Development Committee held last March 22, 2022, Atty. Eduardo R. Cabantac, the Provincial Planning and Development Coordinator presented the draft plan to the members of the committee and was duly approved and endorsed for the consideration of the Sangguniang Panlalawigan. The said plan was approved by the Sangguniang Panlalawigan through SP Resolution No. 2022-14-09 series of 2022.

2. SEAL OF GOOD LOCAL GOVERNANCE (SGLG)

The Seal of Good Local Governance is a progressive assessment system that gives distinction to remarkable local government performance across several areas, highlights integrity and good governance reforms in the continuing pursuit for meaningful local autonomy and development.

SGLG puts emphasis towards integrity and good performance as pillars of meaningful local Autonomy and development.

The Office prepared necessary documents together with Means of Verification (MOVs) for the SGLG Regional and National Assessment for the performance in the two governance areas namely the Business Friendliness and Competitiveness and Social Protection and Sensitivity.

In like manner, the Executive Order creating the Local Economic Development and Investment Promotions Unit, designating a LEDIP Officer, Local Investment Incentive Code, and other supporting documents (e.g. LDC Functionality with satisfactory participations of Civil Society Organizations (CSOs)

Also, the office presented supporting documents for performance indicators specifically on the functionality of Local Development Council and Satisfactory Participation of CSOs.

3. COMPREHENSIVE LAND USE PLAN (CLUP)

Comprehensive Land Use Plan (CLUP) is a document designed to guide future actions and a vision for the future as it has long-range goals and objectives that could affect the local government and the community.

As the Republic Act 7160 provides the creation of Provincial Land Use Committee, the office, being one of the members of the committee is tasked in assessing and reviewing the CLUPs of the different cities and municipalities and ensure its conformity to the Provincial Development and Physical Framework Plan (PDPFP).

To ensure that these mandates were met, the office attended the orientation on Comprehensive Land Use Plan (CLUP) formulation and updating.

Also, the office conducted the 2nd reading on the proposed CLUP of the Municipality of Cordon ad Quirino here in Isabela. The CLUP of these two municipalities were endorsed for the approval of Sangguniang Panlalawigan and fortunately, by virtue of SP Resolution No. 2022-34-03 and SP Resolution No. 2022-34-02 series of 2022, these two CLUPs were approved.

4. EXECUTIVE LEGISLATIVE AGENDA (ELA)

The Executive Legislative Agenda (ELA) is a unifying document corresponding to the term of local elective officials that is developed and mutually agreed upon by both executive and legislative departments of the local government.

It is stated in the first paragraph of the Executive order no. 28-G series of 2019 that the Provincial Government of Isabela's policy is to ensure that all plans, programs and projects are all products of consultation and agreements between the Sangguniang Panlalawigan, stakeholders, sectoral representatives and are outcomes of diligent research, ensure that all of these are in line to the existing laws, ordinances, policies as well as the PGI's Vision, mission as embodied in the province's citizen charter.

The re-established ELA team shall ensure that the Executive Planning and the legislative priorities of the Sangguniang Panlalawigan are harmoniously held together.

Last October 25-26, 2022, the Provincial Government of Isabela (PGI) conducted a Pre-ELA workshop. This workshop aims to increase the capacity of the PGI in crafting the ELA of the province. Workshop outputs are held together and the office was able to come up with a draft ELA which will be included in the first quarter PDC Meeting.

5. PEACE AND ORDER AND PUBLIC SAFETY PLAN (POPS PLAN)

As stated in the Section 16 of the Local Government Code of the Philippines of 1991 LGUs are mandated to maintain and ensure the peace and order in their respective areas of jurisdiction.

By the virtue vested by the Provincial Governor through the Executive Order No. 36 series of 2022, the province re-organized a technical working group who will be in-charge for the crafting of the Isabela Peace and Order and Public Safety Plan.

The Peace and Order and Public Safety (POPS) Plan is a three-year plan consisting of programs and activities that aims to promote and attain a safe, secure, peaceful and progressive community.

The office particularly the Provincial Planning and Development Coordinator being the TWG Chairperson, spearheaded the conduct of a two-day workshop on the formulation of the Provincial Peace and Order and Public Safety Plan. The outputs of the member agencies as well as the members of the TWG during the workshop was set as a basis of the newly crafted POPS plan of the province.

The newly crafted POPS Plan will be presented in the 2023 first quarter PDC Meeting to which it will seek for the committee's approval and endorsement to the Sangguniang Panlalawigan.

6. INTERNATIONAL ORGANIZATION FOR STANDARDIZATION (ISO) 9001:2015

The International Organization for Standardization (ISO) 9001 is defined as the international standard that specifies requirements for a quality management system (QMS). Different organizations use the standard to demonstrate the ability to consistently provide products and services that meet customer and regulatory requirements.

The Provincial Government of Isabela (PGI) despite being an ISO 9001:2008 certified institution, aims to further assure that all its aspects are standardized by upgrading its ISO Certificate from ISO 9001:2008 to ISO 9001:2015 in order to ensure the efficiency and effectiveness of operations for organizational quality and excellent public service.

In line with this momentous event, the office joined various virtual audits and prepared documents for the assessment.

The PGI proved that quality service for Isabeleños is its prime mission as its evidence, its aim for recertification was granted.

7. PPDO goes GREEN...

The Provincial Planning and Development Office joined the One Million Bamboos in One Day project together with other departments of the PGI. This project aims to reforest areas near the Cagayan River specifically in the areas of Cabagan and Tumauini both in Isabela. This reforestation activity is an answer toward eradicating and lessening adverse effects of flooding in the Isabela's flood prone areas and to avoid erosion of the riverbanks of the Cagayan River. The Office was assigned to plant bamboos along the areas of Casibarag Sur and Norte in Cabagan, Isabela.

9. REGULAR BUSINESS MEETINGS

Every year, the office attends on various regular business meetings from the different committees from which the province and the office is a member. In those meetings, different agenda were tackled necessary for the province's and region's development. The committee are enumerated as follows:

- Regional Development Council (RDC) II is the highest planning and policy making body in the region which is a counterpart of the NEDA board in the sub-national level it coordinates and sets the direction of all social and economic development of the region. It also serves as a forum where all local efforts are integrated with regional and national activities.
- Economic Development Committee (EDC) The committee is tasked to integrate sectoral information and statistics in line to the preparation of the annual regional development report Assist the RDC in the translation of the national development goals into specific regional sectoral objectives.
- Infrastructure Development Committee (IDC) The committee is tasked to assist the RDC in the translation of the national development goals and policies into specific infrastructure objectives, strategies, and program/project proposals
- Social Development Committee (SDC) SDC functions as a coordinating unit specifically on planning and programming activities of the Social Development Agencies
- Committee on Development Administration and Communication (CODAC) this committee
 is tasked to review and endorse programs/projects of national government agencies and LGUs
 in the region to the Council requiring national government financial exposure which may
 come in the form of guarantees, national government budget appropriations or subsidies
- Provincial Development Council (PDC) just like the RDC, the council serves as the highest policy making and planning body in the province. PDC sets direction to all provincial development activities.
- Provincial Statistics Committee (PSC) this committee provides direction and guidance to statistical development activities in the province.

 This activity aims to extend the reach of the government by allowing members of the general public through their respective Civil Society Organization to have a voice in the different committees on the provincial government.


