

Highlights of the Activities Undertaken for the Period of July 23 to July 31, 2015

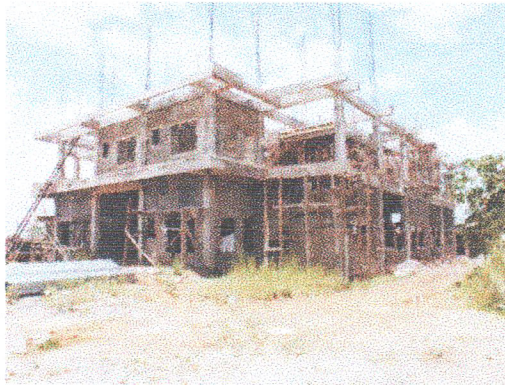
- July 23 - Conducted a short meeting with MSWDO's in the 1st District of the province relative to Crisis Intervention Program – Expanded AICS.

10. Center Head attended a 1 day Orientation on RA 9344 as amended by RA 10630.

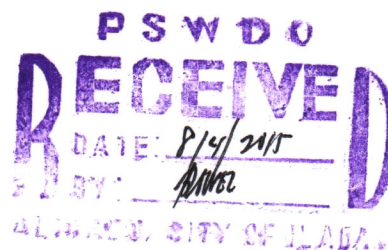
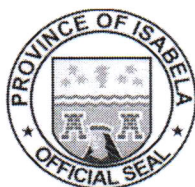
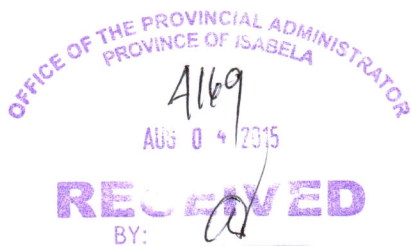
