Echague DCWs Meeting

September 02, 2014 – SWO III Charmiya Rosalina Cruz attended the meeting of Day Care Workers in Echague with Punong Barangay of San Fabian and the President of the Liga ng mga Barangay- Isabela Chapter, Hon Faustino "Kiko" A. Dy on September 02, 2014 at the Provincial Governor's Extension Office in Echague.

Highlight's of Discussions

- Many Day Care Workers have no training related to early childhood care and education
- All newly recruited day care workers have undergone OJT through a one month long detail in a model DCC, however many of them have no training and background on Day Care Service Program
- The Day Care Center have no learning materials

After all the issues and concerns raised by the Day Care Workers, Mrs. Cruz presented the approved project proposal which contained the need to have all day care workers in Echague undergo training workshop and demonstrations related to ECCD in order to equip them with the knowledge, attitude, ability and skills to achieve a child friendly atmosphere day care center and barangay and also the importance of learning materials for kid in the center. The training will start next week. The Trainer is a Preschool and a Grade Teacher with specialization in child development and education in the country and US.

3rd Quarter Meeting of MWDO's

September 03, 2014 - The PSWD Office conducted the 3rd Quarter Meeting among MSWDO's in the province with two (2) invited staff from DSWD Regional Office, Mr. Fanco Lopez, DRRMU Head, and Ms. Constancia Domingo, Administrative Assistant III, with issues and concerns below:

- 1. On Social Pension Program (Ms. Constancia Domingo)
 - Lack of documents in compliance to the requirements of Social Pension Program causes the delay of release of cash to elderly
 - ✓ The NHTSP survey conducted in 2010 was the basis in selecting the beneficiaries
 - ✓ The reason for delisting names of recommended beneficiaries is because their names were not found in 2010 survey



- ✓ The MSWDO requested for consideration to include the names delisted to avoid complaints which is now happening in the office almost everyday
- ✓ Updated survey is requested to avoid bias in the selection of beneficiaries

2. On Grass root Participatory Budget (Mr. Frank Lopez)

Mr. Lopez presented the status of the province in terms of the LGU's requests under the Grassroots Participatory Budget (GPB) Program

- ✓ Release of checks ready for pick up
- ✓ Lists of LGU's with incomplete documents
- Requirements for completion prior to review and approval
- ✓ Schedule of next release before end of 2014
- ✓ LGU's for release of checks in 2015
- ✓ Approved PPA's under the GPB Fund



Mr. Lopez advised the MSWDO's to fasttrack submission of project and other necessary documents for immediate review, approval and release both at the Regional and Central Offices.
