


Such will serve as NYC and DILG's monitoring mechanism for LGUs' compliance to RA 10742, otherwise known as the SK Reform Act of 2015. City/Municipal LYDOs are now consolidating accomplished monitoring reports from SK Councils under their jurisdiction which they shall submit to PYDO for provincial level consolidation to be then submitted to NYC and DILG provincial office. *Attached is the Notice of Meeting dated October 13, 2020.</p>


