**RESOLUTION NO. 1

**A RESOLUTION ADOPTING THE PROVINCIAL YOUTH DEVELOPMENT PLAN (PYDP) 2023-2025
 OF THE PROVINCE OF ISABELA.**

WHEREAS, Republic Act 10742 or the Sangguniang Kabataan Reform Act of 2015 mandates the creation of a Local Youth Development Council tasked to draft, adopt and finalize a three-year development plan anchored on the Philippine Youth Development Plan (2023-2028) and the local development plan of a Local Government Unit;

WHEREAS, Republic Act 11292 or the Seal of Good Local Governance Act of 2019 provides the inclusion of youth development in LGUs as one of the performance criteria to be reviewed through indicators that shall include: (1) adopting a local youth development program; (2) establishing a local youth development council; (3) providing a youth development office; and (4) instituting policies, programs, and systems in order to support and promote the vital role of youth in local governance;

WHEREAS, the Provincial Youth Development Plan shall be the basis of all youth plans to be crafted by the Sangguniang Kabataan, i.e. the Comprehensive Barangay Youth Development Plan (CBYDP), Annual Barangay Youth Investment Plan (ABYIP), and other plans of civic-youth agencies and organizations;

WHEREAS, the three-year Plan shall be the foundation of the Annual Youth Development Action Plan (AYDAP) of the province which shall be yearly incorporated in the provincial Annual Investment Plan.

WHEREAS, the three-year Youth Development Plan aims to address persisting issues related to Health, Education, Economic Empowerment, Environment, Governance, Active Citizenship, Global Mobility, Peace Building and Security, Social Inclusion and Equity, and Agriculture

WHEREAS, the Youth Development Plan seeks to institutionalize the following:

- a. Annual conduct of Gawad Ulang Kabataan (GUK) given to outstanding SK officers, youth leaders, and youth organizations,
- b. Provision of Development Incentives for Thriving Organizations of Youth in Isabela (DITOIY Isabela) as assistance to newly-registered Youth and Youth-Serving Organizations to the Youth Organization Registration Program (YORP) of the province and the National Youth Commission,
- c. The Provincial Youth Summit as the annual gathering of youth leaders in the province to take part in local governance;
- d. Conduct of the Annual Buwan ng Kabataan and International Youth Day Celebration during the month of August;
- e. Conduct of Provincial Youth Caravan – an information, education and service-delivery campaign for the youth to be held in Schools or Universities.
- f. Conduct of the mandatory and continuing training and capacity development for the Sangguniang Kabataan, Council NAGKAISA – PYDC Members, Local Youth Development Officers, and other youth leaders.

WHEREFORE, on motion of Mr. Jhunio Aquino, duly seconded of all the Council members present, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO ADOPT: THE PROVINCIAL YOUTH DEVELOPMENT PLAN (PYDP) 2023-2025 OF THE PROVINCE OF ISABELA;

RESOLVED FURTHER; to forward copies of Resolution to the Hon. Faustino G. Dy III, Provincial Vice Governor and Presiding Officer of the Sangguniang Panlalawigan, and all the members of the Sangguniang Panlalawigan, 2/F Isabela Provincial Capitol Barangay Alibagu, City of Ilagan, Isabela.


