EXECUTIVE ORDER NO. 27 Series of 2019

PROVIDING FOR THE REORGANIZATION OF THE PROVINCIAL LAND USE COMMITTEE (PLUC) OF THE PROVINCE OF ISABELA

WHEREAS, Republic Act 7160 provides for the creation of the Provincial Land Use Committee (PLUC) and its power to review the Comprehensive Land Use Plans (CLUP) of cities and municipalities to ensure their conformity with the Provincial Development and Physical Framework Plan (PDPFP), Provincial Development Investment Plan (PDIP), and the Provincial Disaster Risk Reduction and Management Plan of the province;

WHEREAS, in reviewing Comprehensive Land Use Plans, the PLUC is mandated to consider primarily, the requirements for food production, human settlement, ecological balance and industrial expansion before endorsing the same to the Sangguniang Panlalawigan for final approval;

WHEREAS, the separation, transfer and/or personnel movement in many of the member agencies and offices of the original members of the PLUC necessities the need to reorganize the existing Provincial Land Use Committee of the province of Isabela;

WHEREAS, DILG Memorandum Circular 2016-102 requires the updating of Comprehensive Development Plans (CDPs) and Comprehensive Land Use Plans (CLUPs) of all LGUs, as well as all Provincial Development & Physical Framework Plans (PDPFP), necessitating the corresponding updating, enhancement, and reorganization, if necessary, of all special bodies created by LGUs, to ensure harmonization with the national level, enhancement in planning and budgeting, and the integration of disaster risk reduction and management and climate change adaptation and mitigation (DRRM-CCAM) and other concerns such as conflict sensitivity and those of the marginalized sectors;

NOW THEREFORE, I RODOLFO T. ALBANO III, Provincial Governor of the Province of Isabela, by virtue of the authority vested in me by law, do hereby order to reorganize the Provincial Land Use Committee of the Province of Isabela into the following composition:

FURTHER, it is hereby ordered that the PLUC shall continue to discharge the following functions and responsibilities:

1. Conduct the review of the Comprehensive Land Use Plans of component cities and municipalities before actual submission to the Sangguniang Panlalawigan for approval;
2. Specifically, it shall review plans to:
 - a. Ensure that land use plans of component cities and municipalities are consistent with the Provincial Development and Physical Framework Plan (PDPFP), provincial comprehensive land use plans, and national policies, standards and guidelines;
 - b. Recommend solutions to settle dispute among component units over the alternative uses of land resources;
 - c. Ensure mainstreaming of disaster risk reduction and management and climate change adaption (DRRM-CCA) and other thematic and sectoral concerns into the Comprehensive Land Use Plan (CLUP) of component cities and municipalities;
 - d. Promote the Community-based program for sustainable development; and
 - e. Ensure that such plans are supportive of the objectives set forth in the Urban Development and Housing Act of 1992 (UDHA), Agriculture Fisheries And Modernization Act of 1997 (AFMA), National Integrated Area System (NIPAS Act) and other related laws.

The Committee is required to meet as often as necessary in order to effect Review of all Comprehensive Land Use Plans submitted to the Sangguniang Panlalawigan for consideration and/or approval, to be presided over by the Provincial Planning & Development Coordinator.

The Provincial Planning & Development Coordinator shall issue the required notice of meeting to all the PLUC members at least two (2) weeks before the date of the meeting as well as the agenda therefore.

The Committee may also create a Secretariat and an inter-agency Technical Committee as may be warranted by circumstances that would assist in the conduct and discharge of its functions and responsibilities.

This order shall take effect immediately and let copies hereof be furnished the Presiding Officer of the Sangguniang Panlalawigan, the National Economic Development Authority Regional Officer 02, the Regional Office of the Land Use Regulatory Board, Tuguegarao City, Cagayan, Committee Members, all Local Government Units of the Province of Isabela, and other provincial and national government offices/agencies, for their information and guidance.

All Orders, circulars, memoranda, rules, regulations, and their other issuances or parts thereof that re inconsistent herewith are hereby repealed, modified, or amended accordingly;
