The Bids and Eligibility Requirements such as PhilGEPS Registration, Mayor/Business Permit, Registration Certificate (SEC, DTI, CDA), Annual Income Tax Return of the Interested Bidders must be submitted to the BAC Secretariat on or before the scheduled Opening of Bids. Late bids shall not be accepted;
- 7. Bids must be duly received by the BAC Secretariat in the BAC Office on or before **10 A.M. of December 11, 2020**;
- 8. **BID OPENING** shall be on **December 11, 2020** at around **10:30 a.m.** in the BAC Office and will be made in the presence of the Bidders/Representatives who choose to attend therein;
- 9. In consonance with the provisions of R.A. 9184 and its Revised IRR, PGI-BAC reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders; and
