WHEREAS, according to the same Budget Circular, the grant of Service Recognition Incentive is subject to the availability of funds of the granting local government unit;

WHEREAS, to achieve the Provincial Government of Isabela's desire to provide Service Recognition Incentive to its hardworking officials and employees, there is a need to find sources within the Province's Annual Budget to fund the same;

WHEREAS, records reveal that there are available funds within the item Personal Services (PS) that can be utilized to fund the grant of Service Recognition Incentive to all officials and employees of the Provincial Government of Isabela;

Section 1. The creation of the item "Service Recognition Incentives" within the allotment class *Personal Services* of the 2019 Annual Appropriation of the Provincial Government of Isabela is hereby authorized.

Section 2. The appropriation of funds, in the amount of TWENTY NINE MILLION PESOS (Php29,000,000.00), to the newly created item *Service Recognition Incentives*, and the augmentation of funds to the item *Performance Enhancement Incentive* in the amount of FIVE MILLION FIVE HUNDRED FIVE THOUSAND PESOS (Php5,505,000.00) are hereby authorized.

Section 3. Coverage. All personnel of the Provincial Government of Isabela, whether regular, contractual, or casual in nature, appointive or elective, including the legislative personnel of Sangguniang Panlalawigan Members, are entitled to the grant of Service Recognition Incentive.

Section 4. Service Recognition Incentives. All personnel entitled to receive this incentive shall be granted an amount not exceeding TEN THOUSAND PESOS (Php10,000.00).

Section 5. Guidelines for the Release of Service Recognition Incentive. The PGI shall adhere to the Guidelines provided by Department of Budget Management, particularly Budget Circular No. 2019-6, and other laws, regulations, and rules pertaining to the grant of personnel benefits.

Section 6. Effectivity. This Ordinance shall take effect immediately.
