WHEREAS, the consent of this Body is necessary to the authorize the creation of a new item within the Annual Budget of the Provincial Government of Isabela and to transfer of funds from different accounts thereto;

SECTION 1. The creation of the item "Performance-Based Bonus" within the allotment class Personal Services in the 2019 Annual Budget of the Provincial Government of Isabela is hereby authorized.

SECTION 2. The transfer of the following funds, in the amount of **TWENTY NINE MILLION PESOS (Php29,000,000.00)**, from different accounts of the 2019 Annual Budget of the Provincial Government of Isabela to the newly created item Performance-Based Bonus is hereby authorized:

SECTION 3. COVERAGE. This Ordinance shall cover officials, whether appointed or elected, and employees, whether holding regular, contractual, or casual status, of the Provincial Government of Isabela who has rendered service to the same during Fiscal Year 2018.

SECTION 4. ELIGIBILITY. The Provincial Government of Isabela shall adhere to the Guidelines established by Joint Circular No. 2018-01 issued by the Department of Interior and Local Government and Department of Budget and Management, dated October 11, 2018, regarding the entitlement of individuals to the "Performance-Based Bonus".

SECTION 5. GUIDELINES FOR THE RELEASE OF PERFORMANCE-BASED BONUS.

The Provincial Government of Isabela shall ensure compliance with the Circular provided in the previous Section, and to other laws, rules, and issuances pertaining to auditing, and the grant of personnel benefits.

SECTION 5. This Ordinance shall take effect immediately upon its approval.
