WHEREAS, with our brothers and sisters in Mindanao experiencing the devastation caused by the recent earthquakes, and our rice farmers enduring pains on their livelihood due to the adverse effects of the Rice Tarrification Law, this Body is reminding all officials and employees of all local government units and government offices within the Province of Isabela to observe and display modesty during this Holiday Season and to commiserate with our countrymen's sufferings;

WHEREAS, this Body is also requesting public officials and employees to be mindful with the pertinent provisions of the Code of Conduct and Ethical Standards for Public Officials and Employees regarding modesty and indiscreet spending. Rule VI, Section 8 of its Implementing Rules provide:

"Section 8.Officials and employees and their families shall lead modest and simple lives appropriate to their positions and income. They shall not indulge in extravagant or ostentatious display of wealth in any form. Basically, modest and simple living means maintaining a standard of living within the public official and employee's visible means of income..."
