A RESOLUTION DECLARING ORDINANCE NO. 03 S. 2018 (SUPPLEMENTAL BUDGET NO. 02-2018) IN THE AMOUNT OF SIXTEEN MILLION FIVE HUNDRED SIXTY THOUSAND PESOS (P16,560,000.00) OF THE MUNICIPALITY OF MACONACON, ISABELA OPERATIVE IN ITS ENTIRETY

WHEREAS, Ordinance No. 03 S. 2018, an Ordinance authorizing the appropriation of Supplemental Budget No. 02-2018 in the amount of SIXTEEN MILLION FIVE HUNDRED SIXTY THOUSAND PESOS (P16,560,000.00) from the unappropriated FY 2010-2017 Retained Operating Surplus for the allocation of various appropriations was submitted to this Sanggunian for review pursuant to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

A RESOLUTION DECLARING THE ORDINANCE NO. 03 S. 2018 (SUPPLEMENTAL BUDGET NO. 02-2018) IN THE AMOUNT OF SIXTEEN MILLION FIVE HUNDRED SIXTY THOUSAND PESOS (P16,560,000.00) OF THE MUNICIPALITY OF MACONACON, ISABELA OPERATIVE IN ITS ENTIRETY

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 03 S. 2018 of the Municipality of Maconacon, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following condition:

1. The appropriation for Capital Outlay in the amount of Eight Million Pesos (P8,000,000.00) must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the acquisition of Motor Vehicle (Garbage Truck) in the amount of Two Million Pesos (2,000,000.00) shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018, on Consolidating and Rationalizing the Rules on the Acquisition of Government Motor Vehicles, Adopting a Centralized System of Procurement Therefore, and for Other Purposes and DBM Budget Circular No. 2019-3 dated May 16, 2019 on the Guidelines to Implement the Centralized Procurement of Government Motor Vehicles Pursuant to AO No. 14, S. 2018;

RESOLVED FURTHER, to require the Municipality of Maconacon, Isabela to comply with the herein review finding and/or condition and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Maconacon, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the Sangguniang Bayan of the Municipality of Maconacon, Isabela through the **Honorable MA. LYCELLE KATE D. VICENTE, Municipal Mayor.**
