AN ORDINANCE AMENDING ORDINANCE NO. 05, SERIES OF 2019 TITLED "AN ORDINANCE DEFINING AND NAMING THE COMPOSITION OF THE STANDING COMMITTEES OF THE 10th SANGGUNIANG PANLALAWIGAN OF ISABELA FOR THE TERM 2019-2022" BY REORGANIZING THE MEMBERSHIPS OF CERTAIN COMMITTEES, CREATING THREE NEW COMMITTEES AND ESTABLISHING THEIR RESPECTIVE MEMBERSHIPS, AND INCLUDING AN EFFECTIVITY CLAUSE THEREIN

## **EXPLANATORY NOTE**

**WHEREAS**, in view of the passage of an Ordinance amending the Internal Rules of Procedure of the 10<sup>th</sup>Sanggunian, the Honorable Body held a Legislative Meeting to determine the membership of the three (3) newly-created committees, as provided therein, particularly:

- b) Committee on Sustainable Development Goals.

WHEREAS, upon extensive deliberation among the members of the Sanggunian and careful consideration of their respective expertise, field of specializations, and represented sectors, the membership of the above committees were decided and certain committees were reorganized;

WHEREAS, the Body also considered the renaming of the Chairmanship and Vice-Chairmanship to gender-neutral designations, and further determined that there is a need to include an effectivity clause considering the dynamism of the composition of the Sanggunian;

WHEREFORE, premises considered, and by virtue of the powers vested by law, it is hereby resolved to enact -

Be it ordained by the Sangguniang Panlalawigan of Isabela in its regular session duly assembled :

**SECTION 1.**The position of Chairman in all standing committees is hereby amended to **Chairperson**, and the exercise of such powers shall be recognized as **Chairship.** 

**SECTION 2.** The position of Vice-Chairman in all standing committees is hereby amended to Vice-Chairperson, and the exercise of such powers shall be recognized as Vice Chairship.

**SECTION 3.**The Chairship and Vice-Chairship of the **Committee on Agriculture** is hereby reorganized as follows:

SECTION 4. The Chairship of the Committee on Awards/Citations/Accreditation is hereby vacated by HON. MARCO PAOLO A. MERIS and accorded to HON. VENUS T. BAUTISTA.

**SECTION 5.** The nature of the Chairship of **HON. EDWARD S. ISIDRO** on the **Committee on Commerce, Trade, & Industry** is hereby declared as in hold-over capacity. Such Chairship shall be automatically relinquished in favor of the duly elected Liga ng Mga Barangay Provincial President upon his/her confirmation as an Ex-Officio Member of the Sanggunian.

SECTION 6.The Vice-Chairship of the Committee on Housing, Subdivision and Land Use Classification is hereby vacated by HON. EDWARD S. ISIDRO and accorded to HON. RANDOLPH JOSEPH P. ARREOLA.

**SECTION 11.**The nature of the Chairship of **HON. EDWARD S. ISIDRO** on the **Committee on Market and Slaughterhouse** is hereby declared as in hold-over capacity. Such Chairship shall be automatically relinquished in favor of the duly elected Isabela Provincial Councilor's League Federation President upon his/her confirmation as an Ex-Officio Member of the Sanggunian.

**SECTION 16.** A new section, designated as Section 3, is hereby inserted to read as follows:

"SECTION 3. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon its approval by the Sanggunian and shall cease to be effective on July 1, 2022."
