# ORDINANCE NO. 12 SERIES OF 2019

AN ORDINANCE AMENDING SECTION 198, THE TITLE OF SECTION 199, AND SECTION 199(d) OF ORDINANCE NO. 02, SERIES OF 2001 OTHERWISE KNOWN AS THE PROVINCIAL ADMINISTRATIVE CODE, AS AMENDED BY ORDINANCES NO. 10 and NO. 17, SERIES OF 2010

## **EXPLANATORY NOTE**

WHEREAS, the Provincial Government of Isabela (PGI) adheres to the policy of the State in recognizing the role of the youth in nation-building and in encouraging their participation in public and civic affairs;

WHEREAS, the PGI has provided its youth with programs and services aimed at the development of their skills and overall competence. In line with this, their involvement was institutionalized thru the establishment of a Youth Council which represents various sectors of the youth, and by holding events intended to acknowledge their value and importance;

**WHEREAS**, to further inspire the youth to initiate fruitful change and progress in the Province, the above Chairpersons seek to provide the youth with a venue in which their efforts and contributions are appreciated, and recognized as equal to the achievements of their peers from other fields and professions;

**WHEREAS**, to realize this aim, an amendment of the Provincial Administrative Code concerning the provision of awards to outstanding Isabeleños must be made.

**WHEREFORE**, premises considered, and by virtue of the powers vested by law, it is hereby resolved to enact -

AN ORDINANCE AMENDING SECTION 198,THE TITLE OF SECTION 199, AND SECTION 199(d) OF ORDINANCE NO. 02, SERIES OF 2001 OTHERWISE KNOWN AS THE PROVINCIAL ADMINISTRATIVE CODE, AS AMENDED BY ORDINANCES NO. 10 and NO. 17, SERIES OF 2010.

**SECTION 1.** Section 198 of Ordinance No. 02, Series of 2001, otherwise known as the Provincial Administrative Code of Isabela, is hereby amended to read as follows:

"SECTION 198.ANNUAL SEARCH FOR ELEVEN (11) OUTSTANDING ISABELEÑOS- One of the highlights of the ISABELA DAY shall be the selection of 11 Outstanding Isabeleños. The awards shall be given to outstanding, achiever Isabeleños who have excelled in their own fields of endeavors. It has been initiated (1) to give recognition and commendation to Isabeleños who have contributed significantly to the welfare and development of their fellowmen, community, and our country; (2) to encourage gifted citizens of Isabela to devote their lives to some worthy endeavor; and (3) to highlight their achievements for the other Isabeleños to emulate.

(a) Category of Awards. The following shall be the category of awards:

- 1) Agriculture;
- 2) Education;
- 3) Family;
- 4) Entrepreneurship;
- 5) Law Enforcement;
- 6) Media;
- 7) Culture and Arts;
- 8) Public Service;
- 9) Science and Technology;
- 10) Labor (Worker, Driver, House Helper, etc); and
- 11) Young Achiever."

**SECTION 2.** Section 199(d) of the same Ordinance is hereby amended to read as follows:

**SECTION 199** – Guidelines and Rules for the Annual Search for the Eleven Most Outstanding Isabeleños:

- d. Who may be nominated? Nominees to the Annual Search for the Eleven Outstanding Isabeleños shall be:
  - i. Filipino Citizens;
  - Be at least 21 years of age, except for nominees under theYoung Achiever Categorywho shall not be twenty (21) years of ageor older at the day of the nomination;
  - iii. Be an outstanding achiever;
  - iv. Not be a leader or a member of any subversive or unlawful organization;
  - v. Not be a past recipient of any award under the previous Section;
  - vi. Must have made significant contributions in any of the field listed in Section 196(a) hereof."

**SECTION 3. REPEALING CLAUSE.** All ordinances, orders, and other issuances inconsistent with this Ordinance is hereby repealed.

**SECTION 4. EFFECTIVITY.** This Ordinance shall take effect immediately upon its approval.
