A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HON. RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A CONTRACT OF LEASE WITH ROBERT L. SILANGFOR THE ESTABLISHMENT OF A PGI HELP DESK IN METRO MANILA

WHEREAS, the PGI wishes to extend its programs and services to such Isabeleños, considering that they are more susceptible to mistreatments and more vulnerable to other forms of exploitations;

WHEREAS, in this light, the Provincial Governor desires to establish a PGI satellite office in Metro Manila, particularly in West Triangle Homes, Quezon City, in which a Migrant Workers' Help Desk shall also be installed, to provide Isabeleños in Metro Manila a venue to which they can readily proceed to seek assistance or to forward their grievances;

WHEREAS, the property to which the Satellite Office shall be established is owned by Mr. Robert L. Silang;

WHEREAS, the establishment of the said office necessitates the execution of a Contract of Lease, which further entails the grant of authority from this Body before the PGI can validly enter into the same;

WHEREAS, after careful examination of the Contract of Lease and consideration of its noble purpose, this Body hereby grants the Provincial Governor the necessary authority;

WHEREFORE, premises considered, upon motion of the Honorable Alfredo V. Alili, duly seconded and approved by all the members present in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES: TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HON. RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A CONTRACT OF LEASE WITH ROBERT L. SILANG FOR THE ESTABLISHMENT OF A PGI SATELLITE OFFICE IN METRO MANILA;
