A RESOLUTION AUTHORIZING HONORABLE RODOLFO T. ALBANO III, PROVINCIAL GOVERNOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH PHILIPPINE CHARITY SWEEPSTAKES OFFICE INVOLVING THE SHARE OF PROVINCIAL GOVERNMENT OF ISABELA FROM THE CHARITY FUND

WHEREAS, pursuant to the amended Small Town Lottery Revenue Allocation under Small Town Lottery Circular No. 06-2018 the share of the Provincial Local Government Units was reduced from 1%-0.5% of the 30% Charity Fund Generated;

WHEREAS, the fund that will be accumulated in the Small Town Lottery share shall be utilized for the health programs, medical assistance and services, and charitable services of the Provincial Government of Isabela consistent with the Philippine Charity Sweepstakes Office charter;
