**WHEREAS**, the PGI is a participating Local Government Unit in the implementation of the Department of Agriculture – Philippine Rural Development Project (DA – PRDP);

WHEREAS, in line with its duties and responsibilities under the DA – PRDP, the PGI seeks to establish a Microbial Testing Laboratory to help minimize the potential health risk posed by hazardous microbes and to ensure the microbiology quality of dairy products in the Province;

WHEREAS, the Municipal Government of San Agustin, Isabela has offered the PGI a usufruct over its 450-square meter to serve as the construction site of the said Microbial Testing Laboratory;

WHEREAS, after careful review of the terms and agreements of the Deed of Usufruct, this Body deems it beneficial and advantageous to the Province to grant the Provincial Governor the necessary authority;

WHEREFORE, premises considered, the Sanggunian resolves, as it hereby resolves to enact a –
