WHEREAS, the terms of the 2014 loan expired on September 10, 2019 to which the DBP recommended an extension for another three (3) years or up to September 22, 2022;

WHEREAS, the above loan is still under releasing stage. As such, an execution of a Loan Continuation Agreement between the PGI and the DBP, and a corresponding Promissory Note relative to the same, is necessary to facilitate the continuous loan implementation of the available balances;

WHEREAS, this Resolution is subject to the condition that certified true copies of the said Continuation Agreement and the corresponding Promissory Note be submitted to this Body for review;

WHEREFORE, premises considered, the Sanggunian resolves, as it hereby resolves to enact a -
