- Secretary of the Department of Environmental and Natural Resources, 2001 to 2002;
- Presidential Adviser on Overseas Filipino Communities, 2002 to 2003;
- · Commissioner on Climate Change Commission.
- Awardee, Outstanding Public Policy Achievement Award given by Washington-based Climate Institute.

WHEREAS, the Province of Isabela will forever be appreciative and thankful to the countless accomplishments, meaningful advocacies, and noble causes of Senator Alvarez - the only Senator hailing from the Province of Isabela to date, and for showing to the whole country and the world the quality and capabilities of a proud Isabeleño;
