A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A DEED OF USUFRUCT WITH THE PHILIPPINE RED CROSS FOR THE ESTABLISHMENT OF AN OFFICE, BLOOD BANK, AND LABORATORY IN THE PROVINCIAL CAPITOL COMPOUND

WHEREAS, it is the policy of the Provincial Government to enhance cooperation and promote solidarity with non-government organizations in our mutual aim and shared goal to provide humanitarian services and to promote the general welfare of all people;

WHEREAS, pursuant to this policy, the Provincial Government of Isabela forwarded a request to the Philippine Red Cross for the establishment of an office, blood bank, and laboratory in the Provincial Capitol Compound. Particularly, the Provincial Government of Isabela offered the Philippine Red Cross the exclusive use to a 2,000 square meter area in its Disaster Risk Reduction and Management Complex for such purpose;

WHEREAS, the Philippine Red Cross has extended its kind approval to such request;

WHEREAS, in line with the concurrence of both parties, the two entities agreed to sign a Deed of Usufruct to effectuate their agreement;

WHEREAS, this Honorable Body deems it advantageous and beneficial to the Isabeleño people to grant the Honorable Governor the requisite authority to sign the Deed of Usufruct in behalf of the Provincial Government of Isabela;

WHEREFORE, premises considered, upon motion of Hon. Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A DEED OF USUFRUCT WITH THE PHILIPPINE RED CROSS FOR THE ESTABLISHMENT OF AN OFFICE, BLOOD BANK, AND LABORATORY IN THE PROVINCIAL CAPITOL COMPOUND
