EXPLANATORY NOTE

WHEREAS, Section 4(g) of Republic Act (RA) No. 11469 (the Bayanihan to Heal as One Act) empowered the President to ensure that all local government units (LGUs) are acting within the letter and spirit of all the rules, regulations and directives issued by the National Government pursuant to the said law, and are implementing standards of Community Quarantine consistent with what the National Government has laid down for the subject area, while allowing the LGUs to continue exercising their autonomy on matters undefined by the National Government or are within the parameters it has set, and are fully cooperating towards a unified, cohesive and orderly implementation of the national policy to address COVID-19;

WHEREAS, to effectively carry out the said measures, the National Government allocated funds to augment the resources of the local government units through the Bayanihan Grant to Provinces (BGP);

WHEREAS, on August 4, 2020, the Office of the Provincial Governor submitted a Letter addressed to this Honorable Body requesting that the amount of Thirty-Seven Million Two Hundred Thousand Pesos (PHP 37,200,000.00) appropriated for various accounts under the "Bayanihan Grant to Provinces (BGP)" be reprogrammed to the account "Expenses for the construction/repair/lease/rental of additional space/building
