A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 273 S. 2019 (2020 ANNUAL BUDGET) IN THE TOTAL AMOUNT OF TWO HUNDRED NINE MILLION THREE HUNDRED EIGHTY EIGHT THOUSAND THREE HUNDRED NINE PESOS (P209,388,309.00) OF THE MUNICIPALITY OF DINAPIGUE, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 273 S. 2019, An ordinance authorizing the Annual Budget of the Local Government of Dinapigue, Isabela for Fiscal Year 2020 in the total amount of TWO HUNDRED NINE MILLION THREE HUNDRED EIGHTY EIGHT THOUSAND THREE HUNDRED NINE PESOS (P209,388,309.00) covering the various expenditures for the operation of the Municipal Government of Dinapigue, Isabela and appropriating the necessary funds for the purpose pursuant to the provision of Section 327 of Republic Act 7160, otherwise known as the Local Government Code of 1991.

WHEREAS, the subject Ordinance shows substantial compliance with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160.

A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 273 S. 2019 (2020 ANNUAL BUDGET) IN THE TOTAL AMOUNT OF TWO HUNDRED NINE MILLION THREE HUNDRED EIGHTY EIGHT THOUSAND THREE HUNDRED NINE PESOS (P209,388,309.00) OF THE MUNICIPALITY OF DINAPIGUE, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

## THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED,** to declare the Appropriation Ordinance No. 273 S. 2019 (2020 Annual Budget) of the Municipality of Dinapigue, Isabela **OPERATIVE IN ITS ENTIRETY** effective January 1, 2020, subject to the posting requirements under Section 59 of R.A No. 7160 and subject further to the following conditions:

- 1. The created position of Office Equipment Helper with SG-2 at the Sangguniang Bayan Office is not within the list of position titles found in DBM LBC No. 61 dated March 18, 1996 the revised Index of Occupational Services, position titles and salary grades (IOS) in the Local Government, and DBM BC No. 2004-3 dated March 6, 2004 the Conversion of Positions Performing Staff/Non Technical Functions;
- 2. That the position of Administrative Aide IV (Driver II) SG-4 under the Sangguniang Bayan office shall not be allowed pursuant to the Qualification Standard (Revised 1997) of the Civil Service Commission and the Manual on Position Classification and Compensation Scheme in LGUs. Item 9.2.1.6 under Chapter 9 of the Manual on Position Classification and Compensation Scheme in LGUs states that the classification of Driver position is dependent on the level/rank of the position they serve. Per established standards, the allowable level of the position of Driver II SG-4 is for the Mayor's Office only and for the different offices the position must be Driver I, SG 3. Since the subject position does not conform to the herein prescribed allowable SG allocation, corrections shall be effected without diminution in salary of the concerned personnel. However, subsequent salary increase shall be applied only on the correct classified position;
- 3. This is to reiterate that the Position of Medical Officer VI SG-24/6 is not in accordance with Section 4(d) Local Budget Circular No. 53, which states that:

"The highest level of Position below the Assistant Department Head shall be limited to the allocated Salary Grade for 1st to 3rd Class Municipalities, which is Salary Grade 18"

However, the position is with incumbent, therefore, when the position becomes vacant, it is hereby recommended to be abolished or to be downgraded to a position applicable for a 10 bed capacity hospital and to the equivalent income classification of the municipality.

The following Position Title and Salary Grades should be in accordance with DBM LBC No. 61 dated March 18,1996 on the revised Index of Occupational Services, Position Titles and Salary Grades (IOS) in the Local Government; DBM BC No. 2004-3 dated March 6, 2004 the Conversion of Positions Performing Staff/Non Technical Functions and Local Budget Circular No. 2009-92, the Upgrading of the Affected Positions for Public Health Workers, to wit:

- 5. The appropriation for Philhealth Contribution shall be in accordance with DBM Budget Circular No. 2019-8 dated July 8, 2018, on the Employer (Government) Share in the Health Insurance Premium Contributions to the Philippine Health Insurance Corporation Effective FY 2019 and PhilHealth Circular No. 2019-0009 on the Premium Contribution in the National Health Insurance Program (NHIP) Pursuant to RA No. 11223 Known as the "Universal Health Care Act";
- 6. That the utilization of the appropriation for Capital Outlay must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the acquisition of Motor Vehicles shall be subject to the provisions of Budget Circular No. 2017-1 dated April 26, 2017 and Administrative Order No. 233 dated August 1, 2008 as amended by Administrative Order No. 15 dated May 25, 2011;

- 7. That the appropriation and utilization of 5% LDRRMF in the amount of Ten Million Four Hundred Sixty Nine Thousand Four Hundred Seventeen Pesos (P10,469,417.00) shall be in accordance with the approved Local Disaster Risk Reduction and Management Plan pursuant to RA 10121 and its implementing Rules and Regulations, as supplemented by NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013. Provided further, that the LDRRMF Plan shall be reviewed by the Office of Civil Defense (OCD) pursuant to RA 10121 and its implementing Rules and Regulations supplemented by Local Budget Memorandum No. 78 dated May 15, 2019, copy furnish the Office of the Sangguniang Panlalawigan of the reviewed LDRRMF;
- 8. The appropriation for the 20% Development Fund shall strictly cover only the development projects prescribed and authorized under DILG-DBM Joint Memorandum Circular No. 2017-1 dated February 22, 2017.

That the following appropriations under the 20% Development Fund shall be identified or broken-down into specific/project component indicating the activities/programs to be undertaken and the project site/location in accordance with DILG-NEDA-DBM and DOF JMC No. 1 Series of 2007:

- 1. Completion of Sanitary Landfill Phase 1 for P2,000,000.00
- 2. Concreting of Road Adjacent to Air Strip 800 meters for P9,600,000.00
- 3. Rehabilitation/Restoration of Seawall Portion for P700,958.00

However, the following projects is disallowed:

1. Installation of 2 units Deep Well at Dinapigue Central School for P225,000.00

Said project is not covered by said JMC, however, same can be reappropriated in the General Fund Account provided the no less than 20% requirements for EDF shall be observed, or can be re-programmed with programs/projects activities covered by said Joint Memorandum Circular.

All projects under the 20% Development Fund shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the Municipality of Dinapigue, Isabela to comply with the herein conditions and notify this body of actions taken thereon.
