WHEREAS, the Provincial Government of Isabela would like to laud and extend its gratitude to all individuals and institutions that have decided to donate the funds for the victims of the recent typhoons instead of spending it for celebrations this Holiday Season;

WHEREAS, Isabeleños are hereby reminded that the COVID-19 pandemic still persists and that attendance to or the conduct of Christmas parties and other celebrations during these times will facilitate the spread of the virus and will only bring unnecessary health risks to our loved ones;

WHEREAS, premises considered, upon motion of Honorable Faustino G. Dy III, duly approved and seconded in a session duly assembled, it was –
