WHEREAS, livestock and poultry raising are one of the principal drivers of the Isabeleño economy contributing to livelihood and employment, and generating income for poor farm households;

WHEREAS, the Provincial Government of Isabela recognizes the importance of Science and Technology in increasing productivity and competitiveness of farmers and in creating livelihood opportunities for its people;

WHEREAS, the Department of Science and Technology (DOST), thru the DOST Regional Office No. 02, the Provincial Government of Isabela, and the Office of the First Legislative District of Isabela, aspires to enter into a Memorandum of Agreement for the implementation of the "Post Production Cold Storage Meat" Project in the 1<sup>st</sup> District of Isabela;

WHEREAS, the "Post Production Cold Storage Meat" Project of the DOST adds value on meat products: by providing advancements in storage and preservation of meat and meat products; by augmenting existing meat production and processing facilities; and by improving freezing technique of meat processors;

WHEREAS, this Honorable Body deems the proposed Memorandum of Agreement between the DOST Regional Office No. 02, the Provincial Government of Isabela, and the Office of the First Legislative District of Isabela for the implementation of the "Post Production Cold Storage Meat" Project in the 1<sup>st</sup> District of Isabela to be beneficial and advantageous to the Isabeleño people;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;
