WHEREAS, the Local Government of Sta. Maria, Isabela (LGU Sta. Maria, Isabela) aspires to purchase a certain parcel of land in that will serve as a resettlement area for informal settlers in Sta. Maria, Isabela. In pursuit of this aspiration, it has requested the PGI to extend financial assistance;

WHEREAS, it is the policy of the Provincial Government of Isabela to provide all local government units within its authority with ample support and assistance to stimulate growth and achieve progress in their respective jurisdictions in furtherance of their mutual goals to promote the general welfare of their people;

WHEREAS, the extension of financial assistance to the LGU Sta. Maria, Isabela for the purchase of a parcel of land for informal settlers requires the execution of a Memorandum of Agreement to ensure sound utilization of the amount to be extended and for compliance with established accounting laws, rules, and procedures;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body extends its approval to the Memorandum of Agreement submitted before this Body by the Office of the Provincial Governor for the extension of financial assistance to LGU Sta. Maria, Isabela for the prior-stated purpose. Accordingly, the request of the Honorable Governor to be granted with authority to represent the Provincial Government of Isabela in the execution of such Agreement is hereby granted.

WHEREFORE, premises considered, upon motion of Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled it was —
