WHEREAS, the country is experiencing an unprecedented health crisis due to the spread and pervasiveness of the 2019 Corona Virus;

WHEREAS, in response to the increasing COVID-19 cases in the country and to enhance the capacity of the government to resolve the ongoing pandemic, His Excellency, President Rodrigo R. Duterte, issued Proclamation NO. 929, series of 2020, which placed the entire country under a State of Calamity effective for a period of six months;

ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH REGIONAL OFFICE II FOR THE RECEIPT OF FINANCIAL ASSISTANCE TO AUGMENT THE PROVINCE'S CAPACITY TO RESOLVE THE ONGOING COVID-19 PANDEMIC

WHEREAS, the National Government passed Republic Act No. 11494 or the Bayanihan to Recover as One Act to immediately mobilize, among others, the provision of basic necessities to families and individuals affected by the pandemic and to undertake measures that will prevent the overburdening of the healthcare system;

WHEREAS, the National Government has called for a "whole-of-nation" approach in resolving the COVID-19 crisis, and in addressing concerns and issues resulting from the spread thereof;

WHEREAS, the Department of Health desires to share whatever resources are available in its office to other government offices, especially Local Government Units battling the spread of COVID-19;

WHEREAS, the Province of Isabela was not spared from the onslaught of the pandemic. Resultantly, its citizens suffered as the local economy sustained historic losses while the local healthcare system was overwhelmed due to the rising number of COVID-19 cases:

WHEREAS, the Department of Health (DOH), through the DOH Regional Office II, aspires to extend funds to the Provincial Government of Isabela PGI to enhance the PGI's capability and capacity to address the spread and pervasiveness of COVID-19 in the Province of Isabela;

WHEREAS, the DOH Regional Office II's extension of funds to the PGI necessitates the execution of a Memorandum of Agreement between two parties;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body considers the proposed agreement between the DOH Regional Office II and the PGI to be consistent with the anti-COVID-19 policies and measures of the National Government, and will further develop the capacity and capability of the PGI to resolve this ongoing health crisis hence beneficial and advantageous to Isabeleños;

WHEREFORE, premises considered, upon motion of Honorable Faustino U. Dy IV, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
