A RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO GRANT CALAMITY RELIEF ASSISTANCE TO OFFICIALS AND PERSONNEL OF THE PROVINCIAL GOVERNMENT OF ISABELA

WHEREAS, to strengthen the capacity of the Philippines to address and resolve the spread of COVID-19, which was later declared by the World Health Organization as a pandemic, His Excellency, President Rodrigo R. Duterte, on March 16, 2020, issued Proclamation No. 929 which placed the entire country under State of Calamity effective for a period of six months;

WHEREAS, on September 16, 2020, with the COVID-19 pandemic remaining impactful and pervasive, His Excellency issued Proclamation No. 1021 which extended the effectivity of Proclamation No. 929 to September 12, 2021, unless earlier lifted or extended as circumstances may warrant;

WHEREAS, on November 12, 2020, this Honorable Body placed the entire Province of Isabela under a State of Calamity due to the Cumulative Effects of Typhoons Rolly, Siony, and Ulysses, and Torrential Rains through the passage of Resolution No. 2020-40-1;

WHEREAS, paragraph 6 of the Civil Service Commission Memorandum Circular No. 16, s. 2012 enjoins every agency in the government to come up with long-term plans to address the conditions of its employees affected by a natural calamity/disaster and to include in the said plan provisions for extending immediate relief or other forms of assistance to employees;

WHEREAS, the Provincial Government of Isabela (PGI) recognizes that its officials and personnel experienced unprecedented difficulties due to the spread of COVID-19 and the unceasing rains caused by typhoons and torrential rains. Accordingly, to mitigate the effects of the aforesaid calamities, the PGI aspires to extend Calamity Relief Assistance in the amount of Php15,000.00 to be provided uniformly to its officials and personnel including the Legislative Support Staff of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Honorable Faustino U. Dy IV, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO GRANT CALAMITY RELIEF ASSISTANCE TO OFFICIALS AND PERSONNEL OF THE PROVINCIAL GOVERNMENT OF ISABELA

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Provincial Governor, Honorable Rodolfo T. Albano III; the Provincial Budget Officer, Ms. Elsa M. Pastrana; the Provincial Treasurer, Ms. Maria Teresa Araneta Flores; and the Officer-in-Charge of the Provincial Accountant's Office, Ms. Antonietta Bulan, for their information, guidance and further action.

RESOLVED FINALLY, that the grant of benefits pursuant to this legislative measure shall be made in accordance with budgeting, accounting, and auditing laws, rules, and regulations.
